

# THE LIBRARY COMMISSION MINUTES

REGULAR MEETING 24, February, 2014

The Library Commission convened in a Regular Meeting on Monday, February 24, 2014 at the North Village Branch, 2505 Steck Ave. in Austin, Texas.

- 2. Approval of Minutes from January 27, 2014 Regular Meeting
