## **MEETING MINUTES**

#### A. CALL TO ORDER

Board Chair Kite called the meeting to order at 5:35 P.M. with a quorum confirmed -- Board Vice-Chair Maceo and Board Member Classen arrived at approximately 5:55P.M.. Note: Board Member Newsom left the meeting at 7:10 P.M.

## **B. APPROVAL OF MINUTES**

1. Approve the minutes of the Urban Forestry Board (UFB) meeting of January 15, 2014. Motion made by Board member Newsom, Seconded by Board Member Brewer to approve the meeting minutes of the UFB meeting of January 15, 2014. Approved by Board Members Brewer, Fleming, Kite and Newsom. Board Members Maceo and Classen not present at this time. Motion approved.

#### C. CITIZEN COMMUNICATION

The first 4 (four) speakers signed up prior to the calling of the meeting to order are allowed a three-minute allotment each to address their concerns regarding items not posted on the agenda. There were no citizens signed up to speak.

- 5. Update on formation of Treaty Oak Task Force Working Group. Board Member Brewer presented the information. Task force members met at the Treaty Oak and a variety of concerns were noted. Opportunity exists for outreach and education. Consensus was to create a five-year management plan,

and the initial effort would be an assessment of the more short-term needs for the tree. An assessment protocol is to be developed.

6. Soil Volume Resolution. Michael Embesi presented the information. This process was initiated by the UFB, sponsored by the Mayor's Office, and the directive through the City Manager to address the important issue of soil volume in our street scape and tree plantings in those areas. Six months was given to address this concern, and additional work is left to gather information.
