**PROPOSAL**

---

Demolish a ca. 1925 house.

---

**ARCHITECTURE**

---

One-story, rectangular-plan, side-gabled frame shotgun-style house with a full-width, shed-roofed, independent porch on plain square wood posts; single fenestration with a combination of likely original 1:1 windows and modern replacements.

---

**RESEARCH**

---

The house appears to have been built around 1925 by Gus Becker as a rental property; no houses were listed in city directories on W. Milton Street until the edition of 1927. The first tenants of the house were African-American and later Mexican-American. There was a sizable African-American community in the vicinity – the Goodwill Baptist Church at the corner of Milton and Newton Streets was an African-American congregation.

Around 1938, the house was purchased by Simeon J. and Ray Saunders, who lived here until around 1965. Sim Saunders was a native of Burnet; his father had run a grocery business in Marble Falls in the 1910s. Sim moved to Austin with his parents by 1920 – they were living on E. 2<sup>nd</sup> Street. Sim's father was a paper hanger, Sim and his older brother, Herbert were both house painters. While living in this house, Sim worked as a painter, and as a laundry worker, but mostly had no occupation listed in the city directory listings. His wife, Ray, was a laundry worker. After Sim died in 1958, Ray continued to live in the house until around 1965. The house has been a rental unit since that time.

**STAFF COMMENTS**

---

The house appears in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

---

**STAFF RECOMMENDATION**

---

Release the demolition permit. The house has been altered, and lacks the requisite architectural and historical significance to warrant individual designation as a historic landmark. Due to the alterations to the house, documentation of the structure is not justified.

### **BIOGRAPHICAL NOTES:**

#### **Joseph and Sallie Hitchcock (ca. 1928 – ca. 1930)**

Joseph and Sallie Hitchcock appear in the 1900 U.S. Census for Austin; they were living in the home of her brother, Henry Herbert, and his wife, Louise, on W. 5<sup>th</sup> Street near Dam Boulevard. Joseph Hitchcock was then 33, had been born in Texas, and was a wood hauler. Sallie Hitchcock was then 25, had been born in Texas, and had no occupation listed. They had a daughter, Lela, who was a year old. With them lived Joseph's mother, Elizabeth Hitchcock, a 70-year old Missouri-born widow with no occupation listed. Sallie Hitchcock's brother, Henry Herbert, was 31, had been born in Texas and was a bartender.

The 1910 U.S. Census shows Joe and Sallie Hitchcock living in Marble Falls, Texas, where Joe was a farmer; Sallie had no occupation listed. They had 4 children: Laila, 11; Joe, 7; Herbert, 6; and Allie, 2. All of the children had been born in Texas.

The 1930 U.S. Census shows Joe Hitchcock living with his son, Joe, and Joe Jr.'s wife Laura on a farm on the Oak Hill Road in Travis County. Counted in the same house but not the same household was Joe, Sr.'s son, Herbert, and Herbert's wife, Rhoda. The extended clan included Joe Sr.'s daughter, Lela Clawson with her children. All family members with occupations are listed as farm laborers. Sallie Hitchcock is not mentioned in the census report.

#### **Simeon J. and Ray Saunders (ca. 1938 – ca. 1965)**

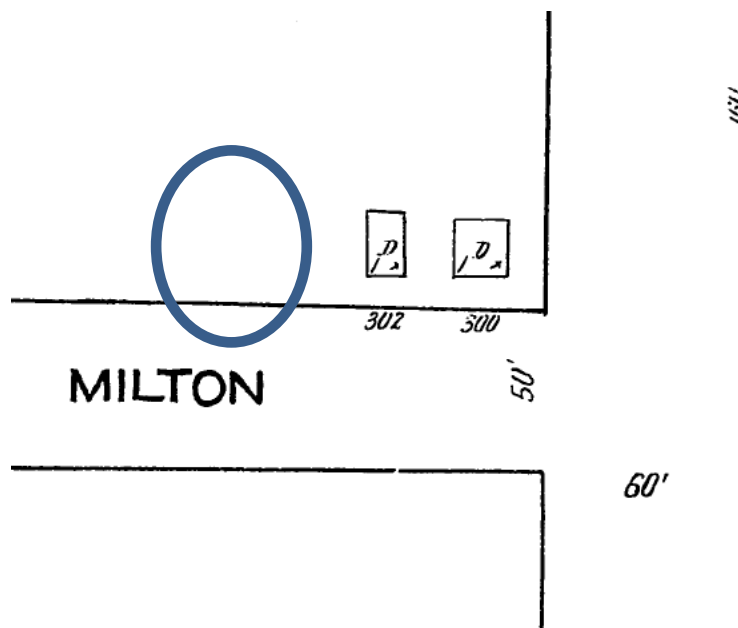
Simeon J. Saunders appears in the 1920 U.S. Census as the 22-year old son of Ernest and Sally Ann Saunders, who rented at house at 1000 E. 2<sup>nd</sup> Street in Austin. Simeon J. Saunders had been born in Texas, and was a house painter, as was his older brother, Herbert. Their father, who had been born in England, was a paper hanger. The 1910 U.S. Census shows the family living in Marble Falls, Texas, where Ernest A. Saunders was a grocery merchant. The oldest son in the family was a house painter; neither Herbert nor Simeon had occupations listed.

**SIM J. SAUNDERS**

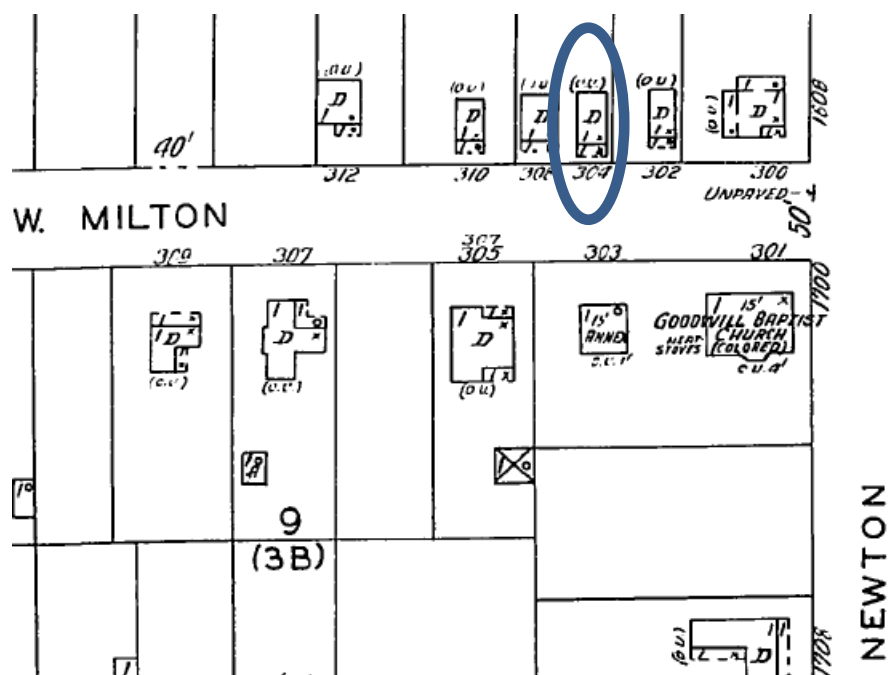
Sim J. Saunders, 60, died in a local hospital Sunday. He has been a resident of Austin 46 years and was employed by the San Jacinto Laundry. He is survived by his wife; one son, James F. Boothe of San Antonio; one daughter, Mrs. Geo. Kidwell of Norwalk, Calif.; two sisters, Mrs. J. L. Monroe of Baytown and Mrs. Mary Irving of Colorado Springs, Colo.; and one brother, W. E. Saunders of Houston.

Funeral services will be held at 10 a.m. Tuesday from Wilke-Clay Funeral Home with Rev. W. C. Hartgrove officiating. Burial will be in Greenwood Cemetery.
