PROJECT SUMMARY

In 2012, the City of Austin Art in Public Places (AIPP) program of the Cultural Arts Division, Economic Development Department sought to commission a professional visual artist to design and create artwork for Phase 1 of the Colorado Streetscape Art in Public Places project in downtown Austin.

The goal of this project was to develop a fresh and innovative approach to design within a restricted environment; consider the diverse community served by the street enhancements, including downtown residents, tourists and the local business community; and consider the unique landscape and history of Colorado Street.

Dharmesh Patel and Autumn Ewalt (Animalis Works LLC) of Austin, TX were awarded the commission and created Cristalline, a series of four polished stainless steel sculptures installed along Colorado Street, between Third

and Seventh Streets. One sculpture was installed in fall 2013; the remaining three sculptures will be installed in March 2014.

For Phase 2 of the Colorado Streetscape Art in Public Places project, the Art in Public Places Panel chose to direct select Dharmesh Patel and Atumn Ewalt (Animalis Works LLC) to continue their project, *Crystalline* for the remaining scope of construction for the Streetscape.

This Recommendation for Council Action authorizes the negotiation and execution of a design and commission agreement for Phase 2 of the Colorado Streetscape Art in Public Places project with Animalis Works LLC.
