Assignments and Goals

Executive

- With United Way, organize and conduct visits to city council, county commissioners, city and county HHS agency officials. Advocate for
 - Restoring and increasing social service contract funding including prevention for next funding competition
 - o Expand scholarships for child care employees
 - o Increase funding for Jeanette Watson salary supplements
- Communicate regularly with City Council, County Commissioners Court, and agency officials with written memos (short) as well as visits.
- Continue to update calendar of city and county budget cycles and key dates for ECC.
- Regular reports and follow-up between ECC and related groups.

Policy and Finance

- Review community plans and make recommendations regarding needs of children and families, including: School Readiness, CHIP, Imagine Austin, and Workforce Development plans.
- Develop strategies to engage parents, and train some parents to attend visits with public officials. Work through Success By 6 parent leadership groups.
- Have regular communication with Workforce Solutions Board and staff, and provide public comments regarding CCDF funds and the annual child care plan to the Texas Workforce Commission.

Providers

- Continue to build relationships with local providers.
- Support partnerships between providers and Licensing representatives.
- Address hot topics and emerging issues, and have discussions with relevant officials to improve public services for children, particularly in underserved areas.
- Coordination with City services for young children, families, and child care providers.

All

- Continue to actively participate in and support the ongoing cycle of the early childhood community planning process including membership on the School Readiness Action Plan Leadership Team.
- Follow-up on School Readiness Action Plan, specifically where the ECC is listed as the responsible entity.
- Continue procedures for regular communication with other city boards and commissions that were begun in 2012.
