Authorize award and execution of a 24-month requirements supply agreement with HACH COMPANY, for the purchase of specialized water quality testing equipment, supplies and chemicals for the Austin Water Utility in an amount not to exceed \$360,000 with three 12-month extension options in an amount not to exceed \$180,000 per extension option, for a total contract amount not to exceed \$900,000.

Amount and Source of Funding

Funding in the amount of \$75,000 is available in the Fiscal Year 2013 – 2014 Operating Budget of the Austin Water Utility. Funding for the remaining nineteen months of the original contract period and extension options is contingent upon available funding in future budgets.

Fiscal Note

There is no unanticipated fiscal impact. A fiscal note is not required.

This contract will provide for a readily available source of supply for HACH water quality testing equipment, supplies and chemicals from the HACH catalog. The supplies under this contract are for water quality monitoring items and analyzers that are used by the water treatment plants, Laboratory Divisions and Collection System Divisions. Supplies will be delivered and stored on an as needed basis to Davis Water Treatment Plant.

The Purchasing Office did an evaluation of twenty line items from the manufacturer's catalog that is commonly used by the Department. A comparison of the list price and the discount price was made to determine if the 5% discount was correct. When the Department places an order for the items under the manufacturer's catalog a 5% discount will be taken from the list price shown.

PRICE ANALYSIS

- a. Sole bid. The initial bid opening date was extended to attempt to get other firms to bid on the project, however, none responded. HACH is the manufacturer of the items covered under the proposed contract.
- b. One hundred twenty-one notices were sent including four WBEs. There were no MBE firms listed. One bid was received, with no MBE or WBE firms responding.
- c. The pricing offered represents a 6% increase from the last contract awarded February 2011. The discount offered of 5% below the listed catalog price remains unchanged.
- d. HACH Company is the current provider for these items.
