Authorize award, negotiation, and execution of a 24-month revenue contract with ECS REFINING, LLC, or one of the other qualified offerors to RFP No. JRD0301, to provide electronics recycling services which will generate for the City an estimated revenue of \$76,436, with four 12-month extension options with estimated generated revenue of \$38,218 per extension option, for a total estimated revenue for the City of \$229,308.

Amount and Source of Funding

The total revenue for Fiscal Year 2013-2014 is estimated to be \$15,925.

Additional Backup Information

This contract is to establish an environmentally sound and reliable solution for recycling used or discarded electronics for the residential customers of Austin Resource Recovery (ARR) and City municipal departments to support Austin's Zero Waste Goals initiative. The electronics recycling program provides an avenue for these electronics to be recovered, refurbished, repaired, or recycled in accordance with the e-Stewards Standard for Responsible Recycling and Reuse of Electronic Equipment developed by the Basel Action Network. Items available to drop off at the ARR Resource Recovery Center (RRC) include televisions, computer, copiers, printers, video players, and telephones, along with other electric devices. The vendor will pick up the material at the RRC, transport it to a certified and permitted electronics recycling facility and ensure it is safely, responsibly and cost-effectively recycled.

The electronics recycling program is a free service provided to Austin Resource Recovery customers to discard used or broken electronics.
