Come to City Hall anytime between 8 am and 4 pm this Thursday and sign up on the little kiosks in the lobby, look for item 56 on the agenda, and click the box that you oppose item 56 and then decide if you want to speak or donate your time to someone you know is going to speak to the City Council during the public hearing which will start sometime after 4 pm. You can park for free under City Hall, 301 W. 2nd St. which is between E. Cesar Chavez Street and E. 2nd Street between Lavaca and Guadalupe Streets, the parking garage entrance is on the west side of Lavaca St. Take your ticket with you and get it stamped by the City Clerk in the lobby.

If you click on the right side of the page PDF documents, **the 2nd one listed is a 20 page staff Review Sheet** that shows letters of opposition, see maps, and the city codes the bar is trying to get a variance for. Planning Commission took no action as a 3-3-3 vote (required 4 votes for firm vote). Staff is recommending Council approve the extension of hours to serve liquor until 2 am every day of the week and to allow them to park cars right next to land used for housing. Join the strong opposition from 3 of the 6 Planning Commissions present at that hearing and numerous residents and community-based groups who are circulating a petition to present to City Council at or sometime after 4 pm this Thursday.
