MEETING MINUTES

A. CALL TO ORDER

Board Chair Kite called the meeting to order at 5:36 P.M. with a quorum confirmed.

Board Member Brown arrived at 6:00 P.M.

Board Member Fleming left the meeting at 7:00 P.M., Board Member Classen left the meeting at 7:30 P.M.

B. APPROVAL OF MINUTES

1. Approve the minutes of the Urban Forestry Board meeting of February 19, 2014.

Motion made by Board Member Classen, Seconded by Board Member Brewer to approve the meeting minutes of the UFB meeting of February 19, 2014. Approved by Board Chair Kite, Board Vice-Chair Maceo, and Board Members Brewer, Classen, Fleming and Newsom. (Board Member Brown not present). Motion passed.

C. CITIZEN COMMUNICATION

The first 4 (four) speakers signed up prior to the calling of the meeting to order are allowed a three-minute allotment each to address their concerns regarding items not posted on the agenda.

D. ANNOUNCEMENTS

- Urban Forestry Board Annual Internal Review Report due March 31, 2014. Board Chair Kite reviewing meeting minutes from last year to gather information.
- Habitat Stewards Training begins March 20, 2014.
- Interdepartmental representatives of the Grow Green team will be at the Zilker Garden Fest on March 29 and 30, 2014. A limited number of free tickets are available at City of Austin libraries.
- The Spring Grow Green Homeowner Training will be on the evening of April 23, 2014, and will focus on the soil-water connection and outdoor water conservation rebates.
- Registration for this summer's Grow Green Landscape Professional Training will open up soon. These full-day classes will be on Wednesdays from July 16 August 13, 2014. \$75.00 for the entire series or \$20.00 for each individual day. - Monthly update -- Public Works Department. Reactionary requests for maintenance of trees. Pruning low limbs. Continuing work in alleyways in Hyde Park.
- Monthly Notification: Removal of protected size trees on parkland that constitute an imminent public safety risk. Presentation given.

- Urban Forestry Program working on request for proposals for internally implemented program to be able to obtain higher quality and more diverse species planting stock, and be able to have better quality control over what's planted on public property and the ability to use Planting for the Future dollars more broadly.

1. Consider action regarding operational modifications within PARD regarding the safeguard of critical root zones in response to recent trenching incidents. Motion made by Board Member Brewer, Seconded by Board Member Brown to recommend to PARD that a review is made of critical, mechanical or physical excavation activities or other potentially tree damaging activities on public land, that a

supervisor, trained in critical root zones and tree protection, other trainer forester or qualified arborist, trained in critical root zones and tree protection is on site during the activity. Board Chair Kite, Board Vice-Chair Maceo, and Board Members Brewer, Brown, Fleming, and Newsom in favor. Board Member Classen opposed. Motion passed.

2. Consider approval of an Urban Forest Grant proposal (Category: Disease or Pest Control) for an oak wilt suppression project on Rae Dell Avenue Motion made by Board Member Brewer, Seconded by Board Member Newsom to approve the grant with the addition of trenching along Arpdale Street to the west and reduction of the trench, to start trench at De Verne Street south and west along Arpdale Street not to exceed \$35,000. Board Chair Kite, Board Vice-Chair Maceo and Board members Brewer, Brown and Newsom in favor. Board Members Classes and Fleming not present. Motion passed.
