PROPOSAL

Demolish a ca. 1937 house and a ca. 1940 rear house.

ARCHITECTURE

The front ca. 1937 house is a one-story, L-plan frame house with vertical siding and single 6:6 fenestration. The rear ca. 1940 house was an addition to the original garage and is a XX

RESEARCH

The houses were built by Mrs. Abbie Allen, the widow of Moses J. Allen, who is listed in early city directories as Rev. Moses Allen. Moses and Abbie Allen lived in various rental houses in South Austin, for a long while on Nickerson Street. Moses Allen died in 1934, and by 1940, Abbie Allen was living as a lodger in the home of Mrs. M.J. Thornberry on W. Johanna Street (M.J.'s son was Homer Thornberry, who later rose to prominence in the legal profession). While still living on W. Johanna Street, Abbie Allen built the front house on this property in 1937 as a rental property. She then built the second house as an addition to the existing garage around 1940, and moved into the rear house around 1946. She lived here until her death in 1955. Since that time, the houses have been rented out to a variety of tenants.

STAFF COMMENTS

Neither house appears in any City survey.

STAFF RECOMMENDATION

Neither house warrants individual landmark designation due to a lack of architectural or historical significance, but both houses would be contributing to a probable historic district in this neighborhood; staff recommends retention and re-use of the houses if possible in an effort to maintain the historic character of Lockhart Drive.

LOCATION MAP

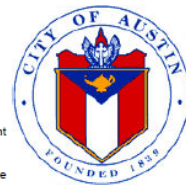


SUBJECT TRACT

BIOGRAPHICAL NOTES

Mrs. Abbie Allen (ca. 1946 – ca. 1955)

Moses and Abba Allen appear in the 1930 U.S. Census as the renters of the house at 1604 Nickerson Street in Austin. Moses Allen was then 65, had been born in Texas, and had no occupation listed. Abba Allen was then 53, had been born in Texas, and had no occupation listed. With them lived Billy and Sally Bruns; Billy Bruns was a baking teacher at the School for the Deaf. Moses J. Allen died in 1934.

Abigail Allen is shown as a lodger in the home of M.J. Thornberry at 109 W. Johanna Street in the 1940 U.S. Census. Abigail Allen was then a 64-year old Texas-born widow with no occupation listed. M.J. Thornberry was also a 64-year old widow; her son, Homer Thornberry, a lawyer, also lived with the women.

MRS. ABBIE FAUBION ALLEN

Mrs. Abbie Faubion Allen, 509B Lockhart Drive, died in a local hospital Monday morning.

She was the widow of the late Rev. M. J. Allen.

Survivors are a nephew, Bill Faubion of Leander, and three nieces, Mrs. Weldon Shows of Houston, Mrs. Margaret White of Austin and Mrs. Agnes Stanford of Burnet; four step-daughters, Mrs. T. N. Barton of Taft, Mrs. W. A.

Dykes of Lubock, Miss Lola Allen of Lubbock and Mrs. C. C. Pinson of San Antonio, and three stepsons, M. J. Allen of San Antonio, Lee O. Allen of Brownfield and J. Rector Allen of Austin.

Services will be on Wednesday at 2:30 p. m. at Cook Funeral Home with Dr. C. W. Hall and Rev. Melton Bohmfalk officiating.

Marvin Hawkins was then 31, had been born in Texas, and was the chief clerk in the State Department of Education. Dorothy Hawkins was then 30, had been born in Alabama, and had no occupation listed. They had 2 children: Mabel Jane, 5; and Marvin John, 1. In addition,

Dorothy's sister, Rebecca Simpson, 24, lived with them. Rebecca was a stenographer in the State Department of Education.

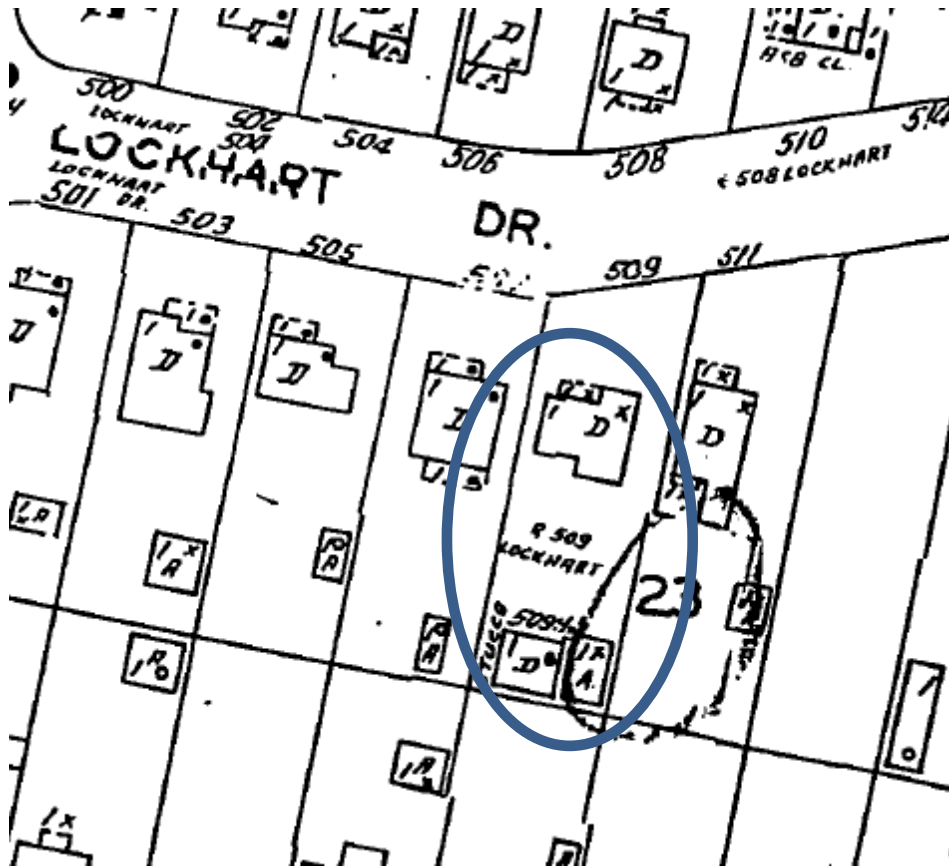
