Jill Fagan Staff Liaison EDD Staff recently informed members of the Robert Mueller Municipal Airport (RMMA) Plan Implementation Advisory Commission (PIAC) of the upcoming City Council Draft Agenda Item regarding a Mueller Pilot Parking Management District.

We want to let you know that a coordinated planning effort has been underway for over eighteen months between the City of Austin Transportation Department (ATD), Economic Development Department (EDD), and Catellus and their consultant Nelson Nygaard to study and plan for public parking needs at Mueller. The study included robust public outreach to residential and commercial stakeholders via focus group meetings, a public workshop, and several surveys. Our Commission's most recent briefing was on May 13, 2014, and at least two of our members participated in many of the prior events.

Out of this work came the recommendation to create a Parking & Transportation Management District (PTMD) to comprehensively address those needs at Mueller. The PTMD would initially be comprised of representatives from the City, including Parking Enterprise, ATD and EDD, and Catellus, Mueller's master developer, and would oversee the phased implementation of various parking and related transportation management tools, including many of which are already currently implemented across Austin, such as:

Parking Enforcement	On-street parking management
Residential Permit Parking	Car & bike sharing
Metered Parking with shared revenue	Public & private off-street parking coordination
Way-finding & signage	

We thank the Council in recognizing the importance of a PTMD at Mueller. In anticipation of your directing the City Manager to implement this program, the Commission would like to note a couple of vital points.

Of considerable concern is access to Mueller's parks. Currently, a very demographically and ethnically diverse population of non-Mueller residents heavily use the parks, especially Lake Park and the Northwest Greenway. Special effort must be made to allow the general public access to free or low-cost parking for these areas until further park development in north and east Austin occurs.

Also urgent is that the pilot program include a shared revenue arrangement, so that a substantial portion of the funds from paid parking spaces are set aside for improvements at Mueller. Signage, way-finding and directions to parking are critical for several years to come, as unfamiliarity and continuing construction will persist at Mueller, potentially confusing non-local visitors in locating facilities like the Dell Children's Medical Center and the coming AISD Performing Arts Center.



 - Plan ahead
 - Coordinate with stakeholders
 - Balance diverse needs
- Build on existing local parking tools and resources
- Create PTMD to comprehensively and proactively plan for and manage public parking at Mueller
- Implement PTMD as pilot at Mueller

Mueller PTMD Opportunities

- Administer RPP and revenue-sharing metered parking program
- Monitor on- and off-street parking
- Coordinate with residents, tenants, owners, and neighbors on parking and transportation issues and opportunities
- Event parking and transportation coordination
- Coordinate with the COA, Capital Metro, and Project Connect on supportive transportation measures
- Coordinate other tools as needed, including validated parking, valet parking, interim construction parking, wayfinding, and trip reduction strategies

Mueller Pilot PTMD Opportunities

 - Management for safety and visibility (e.g. Designating No Parking spaces)

Designation of Zones

- Paid or short-term parking (e.g. 2-hour)
- Customer / Commercial Service
- Valet
- Car sharing
- Ground Transportation (taxi, bus, pedicab)
- Bus loading/unloading



Mueller Pilot PTMD Additional Opportunities

- Special Events Parking
 - May require event / day permits
 - Coordination of off-site parking
- Transportation
 - Bus: Cap Metro & Passenger for groups/tours
 - Project Connect/Urban Rail
 - Traffic calming

- Other Transit/Supportive Measures
 - Wayfinding and signage vehicle & pedestrian
 - Bike corrals and share programs
 - Electric vehicle car charging stations
 - Support for employer trip reduction programs
