  - Update -- Public Works Department. Rob Grotty, Urban Forestry Program Manager presented information.
  - Monthly Notification: Removal of protected size trees on parkland that constitute an imminent public safety risk. Presentation given.
  - Urban Tree Monitoring Protocols: Field Manual for the Minimum Data Set National project looking at standardized method of monitoring trees.
  - A.I.S.D. Forester has been hired.
  - Wasson Avenue Heritage Tree Care presentation given.
  - Tree Protection Training scheduled for 200+ staff engaged in excavations on parkland. Eight classes.
  - Met with Austin Water Utility Executive Team to implement and make contacts with SPOCs about the Urban Forest Plan.
  - Cemetery Tree Inventory to begin soon. Hoping to have data collected by June 2014.
  - Reduced customer service response time from 50 days to 32 days. Goal is 15 days. Non-emergency.

In addition to the motion, a Working Group to be formed of Board Members Classen, Maceo and Fleming and to review the Plan when posted and report to the UFB at the May 21, 2014 meeting.
