ORDINANCE NO. 20140515-013

AN ORDINANCE VACATING APPROXIMATELY 300 SQUARE FEET OF UNCONSTRUCTED ALLEY RIGHT-OF-WAY, AS SHOWN ON THE PLAT OF BELLVUE PARK SUBDIVISION, A SUBDIVISION OF RECORD IN VOLUME 1, PAGE 45, TRAVIS COUNTY PLAT RECORDS TO ALLEN RONALD THROWER AND GWYN LEIGH THROWER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** Council approves the vacation of approximately 300 square feet of unconstructed alley right-of-way, as shown on the plat of Bellvue Park Subdivision, a subdivision of record in Volume 1, Page 45, Travis County plat records to Allen Ronald Thrower and Gwyn Leigh Thrower, owners of the abutting property located at 1507 Inglewood Street, as more particularly described in Exhibit A, attached to and incorporated as part of this ordinance.
- **PART 2.** The area requested for vacation will be used to expand the lot and increase the size of the backyard of the applicant.
- **PART 3.** A drainage easement and public utility easement over the vacated portion is reserved from the vacation by the City over and across the area described in Exhibit A.
- **PART 4.** Allen Ronald Thrower and Gwyn Leigh Thrower have posted funds with the City in the amount of \$540.00, which is the appraised fair market value of the interest in the land being vacated to Allen Ronald Thrower and Gwyn Leigh Thrower, as shown on Exhibit A, and these funds will be deposited after approval of this ordinance.
- PART 5. This ordinance takes effect on May 26, 2014.

North 27°16'50" East, a distance of 6.00 feet to a 1/2" rebar with "Chaparral" cap set in the north right-of-way line of the 12' alley, being the southwest corner of said Lot 11 and also being the southeast corner of Lot 12, Block 11, of said Bellvue Park Subdivision, from which a 3/4" iron pipe found in the south right-of-way line of Inglewood Street, being the northwest corner of said Lot 11 and also being the northeast corner of said Lot 12, bears North 27°16'50" East, a distance of 128.03 feet;

THENCE South 61°56'38" East, with the north right-of-way line of the 12' alley and the south line of said Lot 11, a distance of 50.05 feet to the **POINT OF BEGINNING**, containing 0.007 acres of land, more or less.
