## Subject

Authorize award and execution of a 24-month requirements supply agreement with DXI INDUSTRIES, INC. for the purchase of liquid sulfur dioxide for the Austin Water Utility in an estimated amount not to exceed \$373,520 with two 12-month extension options in an amount not to exceed \$187,760 per extension option, for a total contract amount not to exceed \$747,040.

## Amount and Source of Funding

Funding in the amount of \$62,253 is available in the Fiscal Year 2013 – 2014 Operating Budget of the Austin Water Utility. Funding for the 24-months of the original contract period and extension options is contingent upon available funding in future budgets.

## Additional Backup Information

This contract with DXI Industries, Inc. Houston, TX will establish a supply of Liquid Sulfur Dioxide for the Austin Water Utility (AWU). Liquid Sulfur Dioxide is used at the wastewater treatment plants to treat the chlorinated wastewater prior to release. Sulfur dioxide reduces free and combined chlorine to chloride. This reduction prior to release is required by the Texas Commission on Environmental Quality. The product will be ordered on an as needed basis in one-ton containers for use at the South Austin Regional (SAR) Wastewater Treatment Plant and Walnut Creek Wastewater Treatment Plant.
