Additional Backup Information

This contract is for the purchase and installation of two flash storage arrays, a high performance tiered data/video storage system for use at the Combined Transportation Emergency and Communications Center. These systems will allow for the ability to accommodate storage needs for critical Public Safety systems such as DMAV (in-car video), fingerprinting, booking photos, and crime scene analysis. In particular, the demands of police in-car video are challenging to accommodate because of the massive size of data retained and the video quality and performance expectations of customers.

The performance of an all solid-state solution is unmatched by traditional drives and this system is needed to stay nimble and meet the "on-demand" requirements of customers. Public Safety is continually looking into more advanced video solutions and this system will allow for the provision of the back-end infrastructure for the systems being implemented.
