

ORDINANCE NO.

AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND REQUIREMENTS UNDER CITY CODE CHAPTER 14-8, CERTAIN OTHER FEES AND REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED GREATER EAST AUSTIN YOUTH ASSOCIATION'S 2014 JUNETEENTH PARADE AND CELEBRATION WHICH WILL BE HELD ON JUNE 21, 2014.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The City co-sponsored Greater East Austin Youth Association's 2014 Juneteenth Parade and Celebration will be held on June 21, 2014, along East Martin Luther King, Jr. Boulevard, Comal Street, and Rosewood Avenue with a celebration at Rosewood Park.

PART 2. Council waives or reimburses certain fees and requirements under City Code Chapter 14-8, waives certain other fees and requirements, and authorizes payment of certain costs for the 2014 Juneteenth Parade and Celebration as follows.
