

# DOWNTOWN COMMISSION MINUTES

# REGULAR MEETING WEDNESDAY, MAY 21, 2014

The Downtown Commission convened in a meeting on Wednesday, May 21, 2014, at 301 W. 2nd St. in Austin, Texas.

Chair Bart Whatley called the meeting to order at 5:38 p.m.

#### 3. APPROVAL OF MINUTES OF THE APRIL 16, 2014 MEETING

The minutes from the April 16, 2014 meeting, with a correction to delete the word "workers" from Item 5, third bullet, were approved on a 10-0 vote on Commissioner Galligan's motion and Commissioner Nix's second.

### 4. BARRIERS TO ACTIVATING DOWNTOWN PUBLIC PLAZAS

The Commission heard a presentation from Molly Alexander, Associate Director of the Downtown Austin Alliance.

A motion to support the recommendations of the DAA, as amended, was approved on a 10-0 vote, on Commissioner Galligan's motion and Commissioner MacKinnon's second. The amended recommendations are:

A) Amend Chapter 9-2 of the City Code to allow plazas to obtain an automatically renewable annual temporary sound permits for events with amplified sound. This would apply:

- only for plazas in multi-story buildings in the downtown area that are zoned CBD or DMU
- only for plaza areas that are not reserved for, or licensed by, TABC permit holders
- only for activity that occurs between the hours of 7am–7pm, 7 days a week. Any activity with amplified sound outside these hours must obtain a permit

This permit may be revoked after an annual review

B) Possibly amend Chapter 25-5-2 of the City Code to call out downtown plazas as an approved use for assembly, events, etc. without having to get a temporary use permit.

#### 5. REPORT FROM THE DOWNTOWN PUBLIC OPEN SPACE WORKING GROUP

The Commission heard a presentation from Lynn Osgood, chair of the working group, on recommendations regarding the Downtown Density Bonus Program Public Plaza Standards.

A motion to support the recommendations of the working group was approved on a 10-0 vote, on Commissioner Glover's motion and Commissioner Way's second.

A motion to recommend the City Council approve the master plan as presented was approved on an 8-0 vote, on Commissioner Glover's motion and Commissioner Way's second, with Commissioner Snell abstaining and Commissioner Sokol off the dais.
