PROPOSAL

Convert the existing 1-story house to a 2-story house; construct a rear addition.

PROJECT SPECIFICATIONS

The applicant proposes to construct a second story to the existing 1-story house that will be flush with the front of the existing house. The proposed second-story addition will be painted brick to match the existing brick house and will have a Colonial Revival design that will match the existing style of the house. The new proposed roof will be shingled. The applicant further proposes the demolition of a rear covered patio and construction of an addition at that site. The proposed rear addition will match the rest of the house in terms of materials and design.

STANDARDS FOR REVIEW

The house is contributing to the Old West Austin National Register Historic District, which has no specific design guidelines for additions. General design principles for historic districts encourage additions to the rear of the house with scale, massing, materials, and fenestration patterns complementing the house and other contributing houses within the district. General design principles also recommend against converting one-story houses into two-story houses.




RESEARCH

The existing house was built around 1936 and was a rental house until after World War II. The first tenants of the house were George and Grace Perrin, who lived here from around 1936 to around 1938. William A. and Dink Swearingen rented the house in the late 1930s – he was the president of Swearingen-Armstrong, the local Ford, Mercury, and Lincoln Zephyr dealership. Dr. Virgil S. Rabb, a physician, and his wife, Mary, rented the house in the early 1940s; A private secretary in the State Executive Department rented the house in the mid-1940s. Just after World War II, the house was purchased by Thomas Warren Philibert, and his wife, Mildred, who lived here for over 50 years. Thomas Warren Philibert was a real estate salesman-turned school teacher. While living here, he apparently taught in the schools of Corpus Christi. His wife, Mildred, was a librarian in the Austin Public Library; she was a daughter of T.H. Williams, who had a ladies' department store on Congress Avenue. She controlled an ownership share of the store in the late 1950s and early 1960s.

STAFF RECOMMENDATION

Recommend that the applicant reconsider his plans for the second-story addition. While the proposed new house will be compatible with the architectural character of the district, it completely transforms an existing contributing house to the district. The second-story addition should be pushed back from the front of the house so that the existing one-story presence of the house on the street can be retained. It does not appear that the house has sufficient architectural nor historical significance to warrant individual designation as a historic landmark.

BIOGRAPHICAL NOTES

William A. and Dink Swearingen (ca. 1937 – ca. 1940)

William A. and Lilly Swearingen appear in the 1940 U.S. Census as the owners of the house at 1606 Watchill Road in Austin. William A. Swearingen was then 33, had been born in Texas, and was an automobile dealer. Lilly Swearingen was then 32, had been born in Arkansas, and had no occupation listed. They had lived in Lockhart, Texas in 1935. They had 2 children: Billy, 9, and Bobby, 5. The family had a maid, 25-year old Alvina Gebert, who had lived in rural Travis County in 1935. The 1930 U.S. Census shows William and Lilly Swearingen living in Lockhart, where he was a bank cashier.



William A. Swearingen

William A. Swearingen, age 82, of Austin, died Monday.

Born July 23, 1906, in Lockhart, Texas, he was the son of W.B. Swearingen and wife, Mary V. (Field) Swearingen.

In 1927, he graduated from the University of Texas at Austin with highest honors, where he was awarded the gold key of Beta Gamma Sigma in recognition of his scholastic achievements in the university's school of business administration. He was also a member of the Delta Kappa Epsilon fraternity. He later became a member of the Central Christian Church in Austin.

In 1938, Mr. Swearingen moved from Lockhart to Austin, and purchased the Ford local automobile dealership, which he and his brother co-owned and operated until its sale in 1957.

At the start of World War II, he volunteered for military service; and as a Lt. Colonel in the Air Force he was in command of an AACS unit that installed and operated radio facilities at Air Force bases throughout India. Back in civilian life, he continued the operation of his amateur radio station W5UJ, having first received his license in 1922. He was a longtime member and past president of the Austin Country Club.

Survivors include his wife, Marlon Swearingen; his twin brother, James S. Swearingen; sons, William S. Swearingen of Mountain View, California, and Dr. Robert L. Swearingen of New York; five grandsons, who will serve as pallbearers; a great-grandson; and a great-granddaughter; a nephew, James S. Swearingen, Jr.; and aunt, Mrs. Marietta Swearingen; and stepson, Terry R. Jenkins.

Thomas W. and Mildred Philibert (ca. 1946 – ca. 1989)

The 1940 U.S. Census shows Thomas W. and Mildred Philibert living in Dallas, where they owned a house. Thomas W. Philibert was 38, had been born in Texas, and was public school teacher. Mildred Philibert was 35, had been born in Texas, and had no occupation listed. They had no children living with them.

WARREN PHILIBERT

Warren Philibert, 66, 1505 Westover Rd. died at his residence Wednesday.

An Austin resident for 23 years, he was a former resident of Corpus Christi.

Mr. Philibert was a member of the Episcopal Church of the Good Shepherd. He received his BA at Southwest Texas State College and his MA at the University of Texas. Mr. Philibert was a retired teacher, having taught in Corpus Christi, San Antonio and Dallas.

Survivors include his wife, Mrs. T. W. Philibert, Austin; a sister, Mrs. N. A. Austin, Corpus Christi; a daughter, Mrs. Stanley Hutchins, Falls Church, Va.; and two grandchildren.

A private funeral will be at 4 p.m. Thursday in Weed-Corley Funeral Home. Rev. Charles Sumners will officiate and burial will be in Austin Memorial Park.
