Authorize award, negotiation, and execution of a 12-month requirements service and supply contract with SCHNEIDER ELECTRIC BUILDINGS AMERICAS, INC for the continued maintenance and support of existing safety and security systems in City of Austin facilities in an amount not to exceed \$1,912,800 with three 12-month extension options in amounts not to exceed \$1,442,500 for the first extension option, \$1,415,900 for the second option, and \$1,080,300 for the third extension option, for a total contract amount not to exceed \$5,851,500.

Amount and Source of Funding

Funding in the amount of \$478,200 is available in the Fiscal Year 2013-2014 Operating Budget of various City Departments. Funding for the remaining nine months of the original contract period and extension options is contingent upon available funding in future budgets.

Additional Backup Information

This contract with Schneider Electric Buildings Americas, Inc, Austin, TX, is to continue the maintenance and support of the Continuum Access Control systems currently installed in City facilities. This contract will also allow expansions or relocations of security systems in buildings where it is already in use. The Schneider Electric Continuum system provides integrated security and access control at facilities managed by Austin Public Libraries, Austin Convention Center, Austin Resource and Recovery, Austin Fire Department, Austin Police Department, Austin Water Utility, Communications and Technology Management, Emergency Medical Services, Health & Human Services, Office of the Medical Director, Public Works and CTECC. The Continuum Electronic Security systems consist of Access Control devices (card readers and door controls), Video Surveillance devices (cameras and recorders), Intrusion Detection devices (alarm sensors, motion detectors), and the software required to integrate and manage the system components.

Schneider Electric Buildings Americas, Inc. is the manufacturer of the Continuum Access Control system installed at these City facilities and is the sole provider of maintenance, support, and enhancements for this system and the related proprietary software code and has no authorized resellers or distributors.
