### Additional Backup Information

The contract will provide consulting services for the Planning and Development Review Department (PDRD). The purpose is to conduct an organizational and operational analysis of the PDRD in an effort to increase process efficiency, customer satisfaction, and delivery of accurate and timely services. In addition, the analysis will examine current workflows, organizational structure, facilities, staffing, and service delivery of each division within the department and identify near-term recommendations for improvements. The consultant will provide PDRD with a complete list of prioritized recommendations, an implementation plan, an explicit timeline with detailed actions and concrete milestones for each recommendation.

This request allows for the development of an agreement with a qualified offeror selected by Council. If the City is unsuccessful in negotiating a satisfactory agreement with the selected offeror, negotiations will cease with that provider. Staff will return to Council so that Council may select another qualified offeror and authorize contract negotiations with this provider.
