The proposed ordinance amends Chapter 25-2 to create a new Lake Austin (LA) District zoning overlay that would apply to all property within 1,000 feet of Lake Austin and preserve the environmental protections of the LA District regardless of the zoning of the individual parcels. The ordinance was developed in response to Council Resolution 20130829-113 directing staff to implement in part recommendations from the Lake Austin Task Force ( <u>http://www.austintexas.gov/latf</u> ) final report published in August 2013. The ordinance preserves the conditions of the current LA District except the front and side yard setbacks for which the setbacks of the base zoning would apply within the overlay.
