**MODIFICATION REQUESTED:** The applicant has requested a modification to allow an increase to the maximum gross floor area permitted in Chapter 25-2 of the Land Development Code, Section 2.1 Subchapter F: Residential Design and Compatibility Standards for the construction of a new duplex.

Commissioner Burkhardt noted that doing so would leave the task of "neighborhood watchdog unfulfilled". Commissioner Ingle expressed the desire to focus the RDCC on serving as a

neighborhood planning commission. Motion by Commissioner Bledsoe to recommend to City Council that the RDCC become a Neighborhood Compatibility Commission. 2<sup>nd</sup> by Commissioner Jackson. APPROVED 6-0.

# C-3 Current rewrite of the LDC (land development code)

Commissioner Ingle proposed the RDCC present staff a letter providing a positive statement regarding the McMansion ordinance. Commissioner McGraw noted that the design community has adapted to the ordinance and staff relies on the expertise of the design professionals to show compliance with the ordinance. Motion by Commissioner Ingle for the chair to craft a letter speaking to the value of the McMansion ordinance and send to the Opticos consulting team and assigned city staff prior to June 30<sup>th</sup> comment deadline. 2<sup>nd</sup> by Commissioner Maines. Proposed to circulate via email by Commissioner Burkhardt. APPROVED 6-0
