REGULAR MEETING MINUTES MONDAY, May 5, 2014

The Art in Public Places Panel convened a regular meeting on Monday, May 5, 2014, at City Hall, 301 W. 2nd Street, Room 1029, Austin, Texas.

2. APPROVAL OF MINUTES

Panel Member Little suggested that the artist make a 6'x6' sample of the new technique, possibly in the existing sidewalk. Panel Member Hammonds made a motion to postpone final design approval pending review of the sample. Panel member Walker seconded. Motion passed 7-0.

Susan Lambe updated the panel on the Seaholm Wall, the lighting for West Ave, Sharon Engelstein's new work in Houston, TX and the Artist Roundtable for South Central Waterfront.
