# 5. PROPOSED DISCUSSION AND ACTION ITEMS

a. Approval of Final Design for ABIA Spirit of Austin Lane Cell Phone Waiting Area Project

 -Eric Eley, Artist

Anna Bradley introduced the artist and Matt Caldwell from ABIA. The artist presented the final design of two sculptures for the Spirit of Austin Lane Cell Phone Waiting Area. After a discussion about drainage issues at the site and maintenance concerns, Panel Member Frank made a motion to approve final design. Panel member Hammonds seconded. Motion passed 5-0-0.

- b. Approval of Artist Selection Process and Design for Cesar Chavez Esplanade Phase Two Art in Public Places Project
  - --Anna Bradley, AIPP Coordinator

Anna Bradley introduced artist, Deborah Merksy and Jonathan Thompson of Public Works, and gave an overview of the completed phase of the project and the proposed new extension. AIPP staff recommends the direct selection of Deborah Mersky to work within the same design parameters to create new designs. Panel Member Hammonds made a motion to approve the Artist Selection Process and Preliminary Design. Panel member McCray seconded. Motion passed 5-0-0.

- c. Discussion and Possible Action to Change Bylaws Regarding Panel Member Terms and Vacancies

Meghan Wells explained new proposed language for the bylaws intended to streamline the tracking of AIPP Panel member terms. When a vacancy happens, the new appointee will begin a new term instead of filling an existing term. After confirming the Bylaw revision process, no action was taken. This will come back next month for action.

# 6. STAFF BRIEFINGS

Anna Bradley presented an update on the fabrication and installation of the Auditorium Shores sculpture. Meghan Wells presented updates for Carrie Brown on the grand opening of the AIPP YMCA Community Garden and announced that AIPP received the YMCA annual award for Community Partner. Laura Garanzuay has gone back to her original approved design for the sidewalk enhancement at 2<sup>nd</sup> St. at Guadalupe, so no further action is needed. Jean Graham announced the upcoming dedications for AIPP artworks at the Lady Bird Lake Boardwalk Trail, Westenfield Pool, Bartholomew Pool, and Barton Springs Pool. The remaining AIPP funds for the Lady Bird Lake Boardwalk Trail are still on hold and there is a Council item coming forward that calls for a public art master plan for the Trail, funded by the Trail Foundation.
