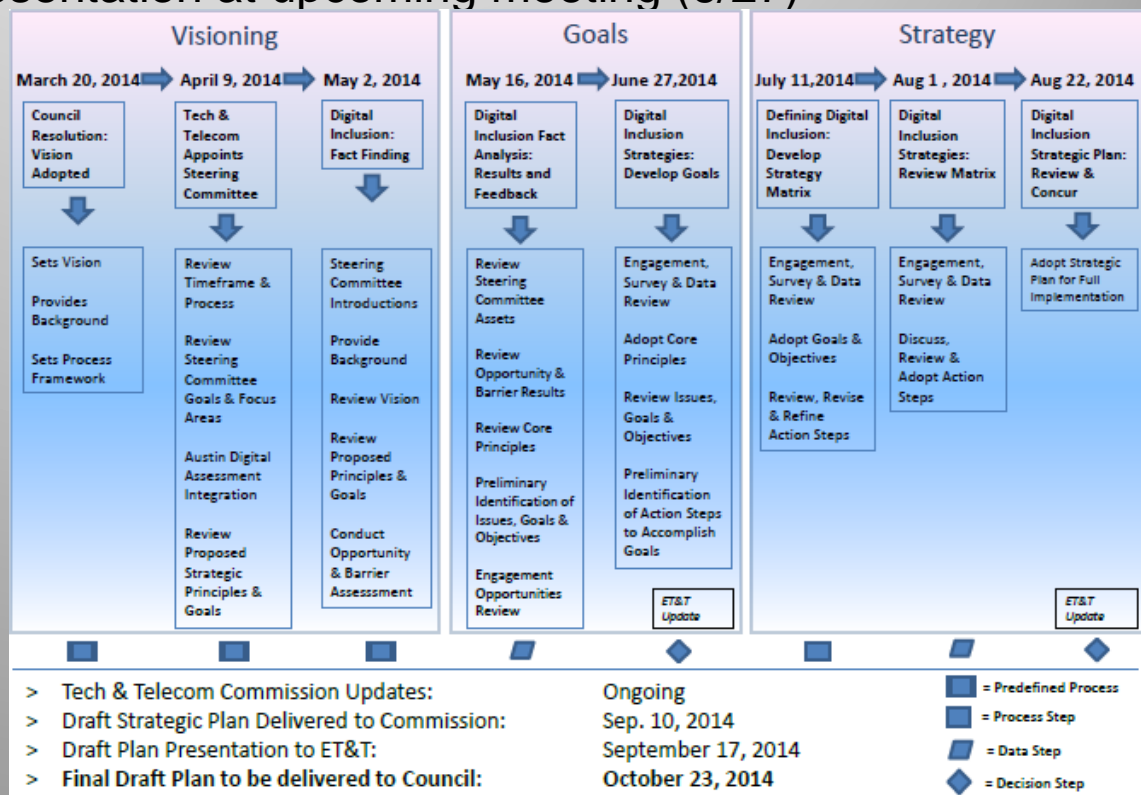

Framework for Inclusion

Availability

Sufficient bandwidth is available for multi-user environments, such as educational institutions, public libraries, medical facilities, and other organizations, to support current needs and future network demand.

Affordability

Programs that subsidize monthly Internet subscription costs are available to low-income households.

Design for Inclusion

What type of digital technologies do Austin residents need? Do residents have the training to maximize available digital technologies?

Public Access

What is the availability of technology to Austin residents?

Relevance

How many people use digital technologies to improve their employment skills? What types of education and supportive services will Austin residents need?

Digital Literacy

Training needs and assets in the community are identified and evaluated, and a strategy for meeting the digital literacy needs of the community is adopted.

Consumer Safety

A strategy for training and educating community members about safeguarding personal information, using parental controls, protecting vulnerable populations from online bullying and exploitation, maintaining systems free of viruses, and protecting against other forms of online abuse has been adopted by all providers of Internet services and content.



IMAGINEAUSTON

The Imagine Austin comprehensive plan serves as a roadmap for shaping the future of Austin and documents the community's vision for the next 30 years, including promoting the prosperity of all, which is one of six key noted challenges, but as yet does not address digital inclusion.

- *Commission asked to review staff generated proposals for recommendation to the Steering Committee at their June 27, 2014 meeting.*
- *The first draft of the annual report and amendments will be at a committee of Planning Commission on July 14, 2014.*

Potential Amendments

- **Create a policy**, probably in the **Economy Building Block** (Chapter 4), that discusses the principles of digital inclusion such as “Provide ongoing and coordinated digital services to meet the needs of the community by ensuring that all residents have access to internet connectivity, hardware availability, digital literacy training, and access to relevant information.”
- **Create an action** in the **Economy Building Block** (Chapter 5) to develop the Digital Inclusion Strategic Plan such as “Initiate the development of the Digital Inclusion Strategic Plan.”
- **Amend Priority Programs 3** (Economic Development) and/or 7 (Healthy Austin) to include this initiative.

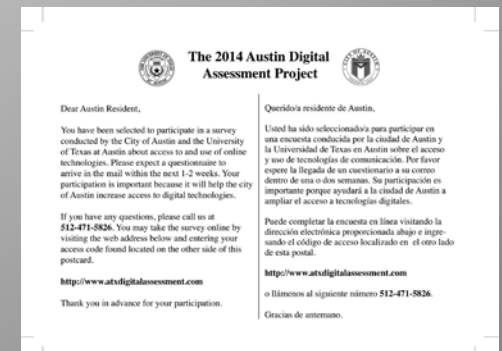
Phase I: Update

- Postcards announcing survey went to sample of 15,000 residents on 6/4.
- Phase 1: Survey will begin to appear in mailboxes the week of Monday, June 16th.
- Respondents are encouraged to complete the survey as soon as possible. Phase 1 of the survey will close in mid-July.



Phase II: On the Radar

- Phase II: (Mid-July) UT will no longer accept mail-in or online survey responses—the Qualtrics link dedicated to the Phase 1 survey will be deactivated. “Phase 2” survey, which is the exact same survey with a different Qualtrics link.
 - Working with community partners including Skillpoint Alliance, Austin Free-Net, Austin Public Libraries, etc. Our community partners will encourage their clients to take the survey, and this data will be informally compared with the statistically valid portion of the survey.

Digital Assessment survey to set digital priorities to improve technology access for Austin residents

The Austin Digital Assessment, a residential technology survey, will be mailed to 15,000 homes this week.

The City of Austin and its research partner, the University of Texas Telecommunications and Information Policy Institute, seek to evaluate and assess residents' access to technology resources, training programs and to identify unmet needs and barriers.

This study will help guide City of Austin decisions and help those involved in digital efforts and design better services. Phase I of the survey closes in mid-July.

The Austin Digital Assessment will delve into education, health care, civic engagement, social connections in Austin. Topics will include:

- Access – What is the availability of technology to Austin residents? Are there barriers?
- Adoption – What type of digital technologies do Austin residents need? Do they have access to the technologies?
- Application – How many people use digital technologies to improve their types of education and supportive services will Austin residents need?

Responses are confidential and will inform future decisions that will ensure every opportunity to be fully engaged in digital society and able to access and use digital technology in Austin.

Survey results will inform the development of the City's Digital Inclusion Strategy.
