Authorize award and execution of a 24-month requirements supply contract with CARBON ACTIVATED CORPORATION, for the purchase of powdered activated carbon for the Austin Water Utility in an amount not to exceed \$1,145,600, with two 12-month extension options in an amount not to exceed \$572,800 per extension option, for a total contract amount not to exceed \$2,291,200.					
Amount and Source of Funding					
Funding in the amount of \$47,734 is available in the Fiscal Year 2013 – 2014 Operating Budget of the Austin Water Utility. Funding for the twenty-three months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract with Carbon Activated Corporation of Phoenix, AZ will provide the Austin Water Utility with a readily available supply of powdered activated carbon that will be purchased on an as needed basis. Powdered activated carbon is a non-toxic water treatment chemical used to control taste and odor in the treatment of tap water. The chemical has been approved by the Environmental Protection Agency and the Texas Commission on Environmental Quality.
