

WATERFRONT PLANNING ADVISORY BOARD MINUTES

REGULAR MEETING
14 JULY 2014

The Waterfront Planning Advisory Board convened in a regular meeting on 14 July 2014 in the Boards and Commissions Room at City Hall in Austin, Texas.

Chair Brooke Bailey called the Board Meeting to order at 6:12 p.m.

A. APPROVAL OF MINUTES

The minutes from June 2, 2014 special-called meeting and the June 9, 2014 regular meeting were deferred to the August 11 meeting because of a lack of quorum of members from previous meting.

B. CITIZEN COMMUNICATIONS – Deena Estrada, the Boards & Commissions Coordinator, discussed recommendations by the Transition Task Force regarding the Waterfront Planning Advisory Board, and asked Board members to complete the survey that was e-mailed to each of them.

C. NEW BUSINESS

- 1. Presentation by The American Society of Landscape Architects, Austin Section, regarding their CodeNEXT issue paper. Presented by Eleanor H. McKinney, ASLA, GRP. A motion to support the intents and concepts of the ASLA CodeNEXT paper was approved 4-0 on a motion by Chair Bailey and a second by Mr. Zickert, with Mr. Hutton, Mr. Mann and Mr. Rindy absent.
- 2. **Red Bluff Hotel** (Case No. SPC-2014-0175A) Presentation, discussion and action to consider recommendation of three Waterfront Overlay variances for a proposed hotel and restaurant at 4701 Red Bluff Road. The variances are from the following Land Development Code sections, and described below:

- 1) LDC Section 25-2-721(B)(1), which prohibits parking areas and structures within the primary setback;
- 2) LDC Section 25-2-721(C)(1), which permits only "fountains, patios, terraces, outdoor restaurants and similar uses" within the secondary setback; and
- 3) LDC Section 25-2-721(C)(2), which limits impervious cover in the secondary setback to a maximum of 30 percent.

Owner: Red Bluff Partners, LLC (Will Steakley). Applicant: Big Red Dog (Aaron Bourgeois). Staff: Michael Simmons-Smith, Planning & Development Review Department. Staff Recommendation: Recommended. Vice-Chair Schultz recused himself, and this item was postponed to the August 11 meeting because of a lack of quorum.

- 3. Update, discussion and possible action on the South Central Waterfront Area Plan Initiative. Staff: Alan Holt, Planning & Development Review Department.
- 4. Discussion and possible action regarding the density bonus plan for numerous Waterfront Overlay subdistricts.
