Authorize award and execution of a 36-month requirements supply contract with PENCCO, INC., for the purchase of liquid ferric sulfate for the Austin Water Utility in an amount not to exceed \$1,383,912, with three 12-month extension options in an amount not to exceed \$461,304 per extension option, for a total contract amount not to exceed \$2,767,824.					
Amount and Source of Funding					
Funding in the amount of \$461,304 is available in the Fiscal Year 2014 – 2015 Operating Budget of the Austin Water Utility. Funding for the twenty-four months of the original contract period and extension options is contingent upon available funding in future budgets.

Additional Backup Information					

This contract with Pencco, Inc. will provide for the supply of liquid ferric sulfate, which is used by the Austin Water Utility for water purification processes. This chemical is added to raw water during the purification process and causes sediment, bacteria, and other suspended particles in the water to aggregate into a mass for removal. This chemical is essential in the treatment process to ensure the quality of the City's water supply and to meet the Environmental Protection Agency's regulations. The product will be purchased on an as needed basis and delivered and stored at the Davis Water Treatment Plant, Ullrich Water Treatment Plant, and Water Treatment Plant # 4.

PRICE ANALYSIS

- Adequate competition.
- Forty-five notices were sent, including 2 MBE and 2 WBE firms. Three bids were received, with no MBE or WBE firms responding.
- The pricing offered represents a 28% decrease from the previous contract awarded August 2011. This decrease can be attributed to the decrease in the cost of iron ore and sulfuric acid used in the manufacturing of liquid ferric sulfate.
- Pencco is not the current provider.

APPROVAL JUSTIFICATION

- Low bid.
- The Purchasing Office concurs with the Austin Water Utility's recommended award.
