2. Adoption of agenda.

4. Approval of minutes – August 13, 2014 Commission Regular Meeting

Minutes from the Commission regular meeting of August 13, 2014 were approved on Commissioner Hoen's motion; Commissioner Ramsey's second on a vote of 6-0. (Commissioner White absent)

5. 2015 GTOPs Review working group update and possible recommendation. (John Speirs) (wp5)

Motion to approve recommendations Section 1-4 as presented with changes/updates to section 1 to allow for applicants to categorize themselves in 1-4 of the priorities in their order of preference more description to the categories was approved on Commissioner Ramsey's motion; Commissioner Parker's second on a vote of 6-0. 6. Review of FY 2014-2015 budget actions. (Rondella Hawkins) (wp1)

Rondella Hawkins, Manager of the City of Austin Office of Telecommunications & Regulatory Affairs (TARA) reported that the budget funding for GTOPs stayed the same as last year (\$200,000.00). AISD will be funded \$300,012.00 from PEG funds. Austin Free-Net's funding stayed the same as last year (\$197,774.00). ChannelAustin's funding stayed the same as last year (\$450,000.00). Telecom & Regulatory Affairs was budgeted 1 full time employee (FTE) for the digital inclusion programs.

7. Digital Inclusion Strategic Plan update including update on the Austin Digital Assessment. (John Speirs) (wp4)

John Speirs, Program Coordinator with the City of Austin Office of Telecommunications & Regulatory Affairs reported that September 10th is the scheduled date for the draft Digital Assessment. Sharla Chamberlain is working to get GIS mapping of the survey.

Sharla will also be presenting the Draft Digital Inclusion Strategic Plan to the Community Action Network.
