

# Radisson Restaurant Deck Contract Background and Key Contract Terms

### **Background:**

In 1993, the City and the Radisson entered into a agreement for the construction of a deck on parkland.

- The deck was 1,125 square feet
- Open to the public
- No commercial activity on the deck.
- The deck was in place from 1993-2013, and removed in September, 2013.
- The Radisson has maintained and improved the parkland adjacent to the deck for the last 20 years.

### **Legislative History**

 2003 State Law authorizes the City to sell, lease or convey up to one acre (in aggregate) of land to property owners that are adjacent to the land.

### **Proposes Contract Key Terms:**

#### Term and Site

- Term 20 years, with two 5-year extensions
- Lease area upper deck area 2,000 sq, ft.
- Public space lower deck area 1,060 sq. ft.

#### Design and Construction

- Radisson to fund, design, and construct upper and lower deck with City review and approval
- o Improvements to include ADA access to lower deck from Congress Ave.

#### Management, Operation and Maintenance

- Radisson to operate and maintain restaurant on upper deck
- o Radisson to maintain public open space on lower deck
- o Radisson to maintain parkland adjacent to the deck

### Operating Hours and Rules

- Leased space hours to coincide with the hours of operation of the hotel restaurant
- Public space to follow Park Rules and hours of operation

### Revenue tracking and Rent

- o Radisson to track all sales generated on the leased space
- Rent Still to be negotiated

# Background







- In 1993, The City and the Radisson Hotel entered into an Agreement for the construction of a deck on parkland
  - □ 1,125 sq. ft. deck
  - Open to the public
  - No commercial activity on deck
  - Deck was removed in Sept. 2013
- Maintenance & Improvement:
  - The Radisson Hotel has maintained the parkland adjacent to the deck for the last 20 years.
    - Grounds maintenance
    - Park improvements
- Legislative History

# Deck Contract – Overview and Key Terms



### Term and Site:

- □ Term 20 years, with two 5-year extensions
- □ Lease area upper deck area 2,000 sq. ft.
- Public space lower deck area 1,060 sq. ft.

- Radisson to fund, design, and construct upper and lower deck with City review and approval
- Improvements to include ADA access to lower deck from Congress Ave.

- Radisson to operate and maintain restaurant on upper deck
- Radisson to maintain public open space on lower deck
- Radisson to maintain parkland adjacent to the deck

## Operating Hours and Rules

- Leased space hours to coincide with the hours of operation of the hotel restaurant
- Public space to follow Park Rules and hours of operation

## Revenue Tracking, Sharing and Rent

- Radisson to track all sales generated on the leased space
- Rent and Revenue Sharing still to be negotiated



# Proposed Deck



Proposed Deck (3,460 sq. ft.):

Upper Deck (commercial) - Restaurant (2,400 sq. ft.) (~ 400 sq. ft. on Radisson property) Lower Deck (non commercial) – Public Space (1,060 sq. ft.)

### Previous Committee, Board and Council Actions:

- 9/24/13. Parks and Recreation Board. Briefing on proposal to the Parks and Recreation Board
- 10/14/13. Land and Facilities Committee of Parks Board. Recommendation to the Parks Board to support negotiation of agreement with the Radisson Hotel.
- 10/22/13. Parks and Recreation Board. Unanimous recommendation with a 5 to 0 vote for City Council to authorize negotiation of a contract with the Radisson Hotel for the development and operation of a restaurant deck and public terrace.
- 2/27/14. City Council. Authorized negotiation of an agreement with the Radisson Hotel for the construction and operation of restaurant deck and public terrace.
