

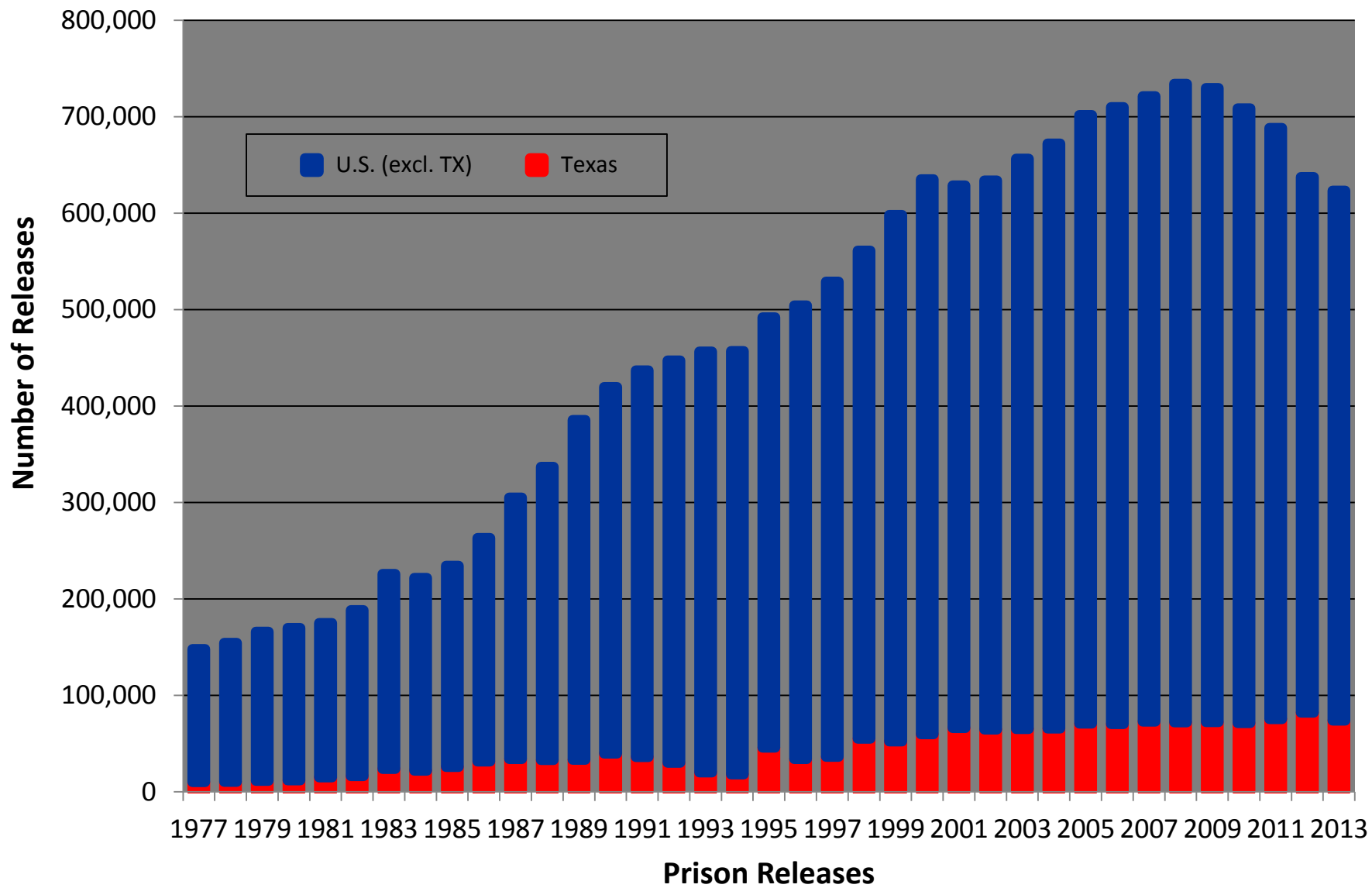

U.S. Prison Releases, 1977 - 2013



The data reveals...

U.S.:

- **650,000** released from prison each year
- **850,000** on parole; **4M** on probation
- An estimated **65M** to **100M** persons have a criminal record in the US

Texas:

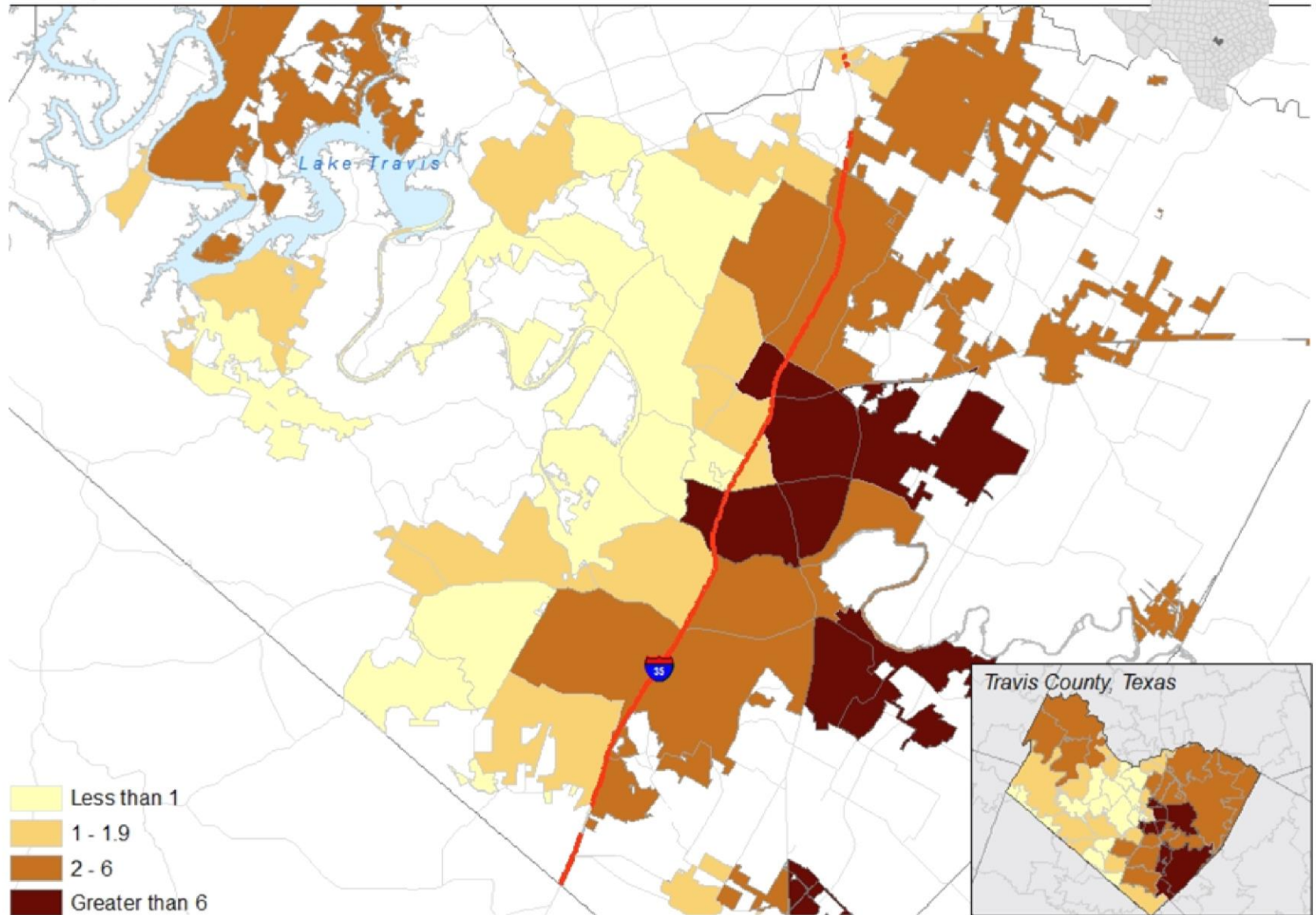
- **77,000** released from prison each year
- **85,000** on parole
- **162K** on felony probation, **96K** on misd. probation
- **12M** with a criminal record

Local:

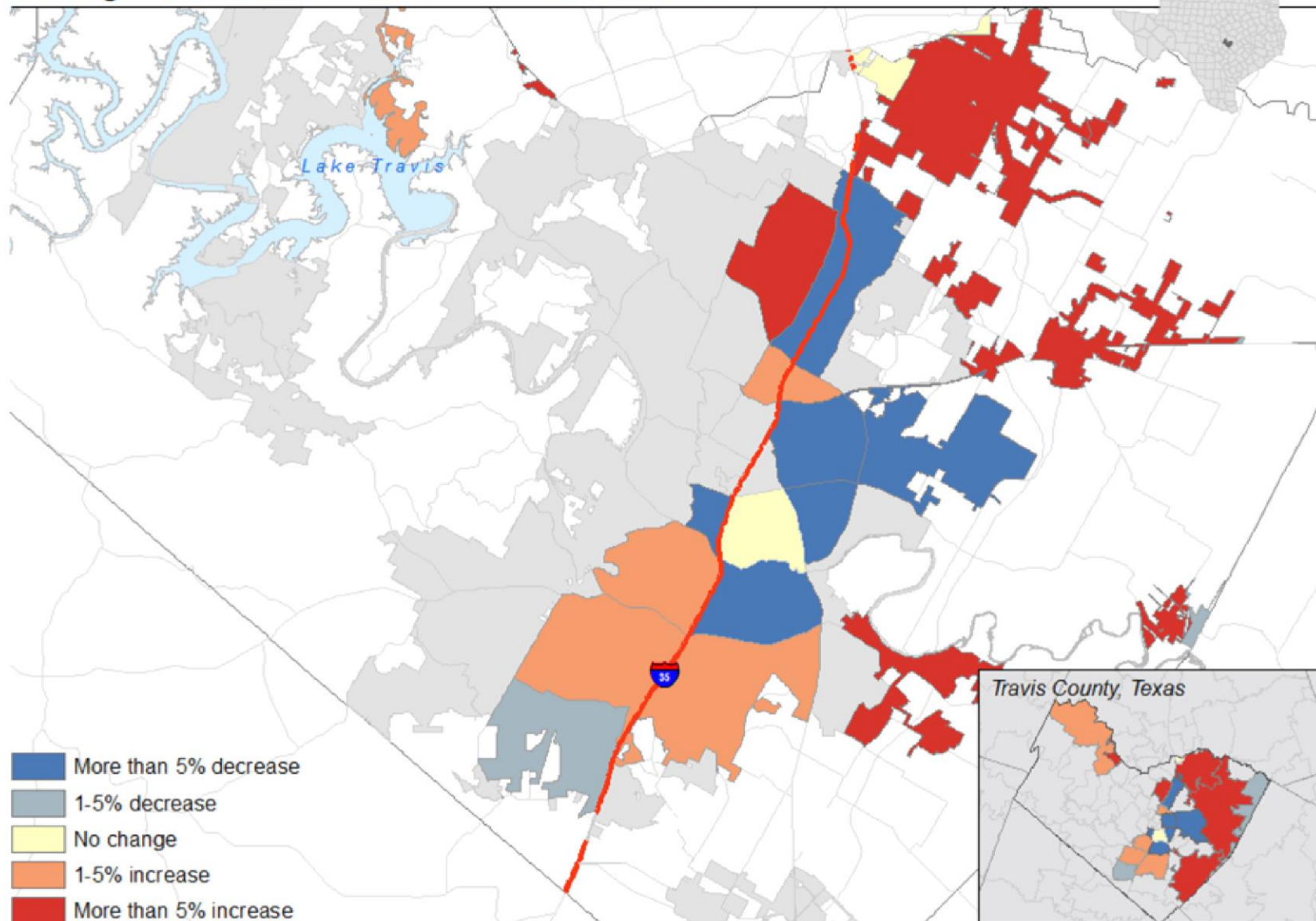
- **2,700** released from prison each year
- **2,800** on parole
- **16,000** on probation

Benefits-to-Cost of Rehabilitation and Reintegration Programs

- For every dollar spent on community-based employment training and job assistance programs, there is a benefit of **\$44.66**.
- For every dollar spent on non-intensive drug treatment in prison, there is a benefit of **\$29.40**.
- For every dollar spent on cognitive behavioral therapy for high to moderate-risk offenders, there is a benefit of **\$26.47**.
- For every dollar spent on intensive drug treatment in prison, there is a benefit of **\$13.41**.
- For every dollar spent on outpatient drug treatment in the community, there is a benefit of **\$9.42**.
- For every dollar spent on policing, there is a benefit of **\$6.52**.

The data reveals...

- We spend \$3.3 billion each year in Texas on prisons, which equates to **\$21,000** per prisoner per year.
 - By comparison, the federal poverty threshold for a single member household is \$11,670.
- State funding for probation: \$300 million.
- State funding for parole: \$165 million.
- Local funding for APD: \$369 million.

 - ✓ Developed presentation to employers on “Benefits of Hiring Former Offenders”
 - ✓ Conducted presentations at Sheriff’s Office Vision Summit, Restorative Justice Conference, State Reentry Coalition, Social Services Case Management Network on “Re-Entry 101” and “Success Stories of Formerly Incarcerated”
 - ✓ Quarterly Newsletters sharing national and local re-entry trends, best practices, events

A/TCRRT Activities, *con't*

- **Housing advocacy:**
 - ✓ Update of *Transition Planning for Homeless Persons Leaving Local Jails* Initiative
 - ✓ Collaborating with ECHO on Coordinated Assessment system
 - ✓ Advocating for Housing First PSH and reduction in criminal history screening criteria for housing providers and mainstream landlords
- **Employment advocacy:**
 - ✓ Informing local partners on EEOC Enforcement Guidance on Using Arrest and Criminal Backgrounds in Hiring Practice
 - ✓ Editorial in local news paper
- **Women Reentry Services:**
 - ✓ Launched initiative
- **Community Service:**
 - ✓ Resource fair booths provided over 1,200 pieces of literature on community supports/services to over 500 individuals
