A person that receives an administrative citation has the right to a hearing on the violation. The penalty for an administrative citation will be monetary. The administrative citation will include the time and place for a hearing. The hearing will be conducted by a hearing officer. An individual that does not appear for a hearing on the violation or pays the administrative citation without a hearing							

is considered to admit liability for the violation.

A monetary penalty and costs will be imposed when an individual is found to be liable for a violation. If the individual attends the hearing and is found liable, the individual may appeal the determination by filing a petition in municipal court.

An order issued pursuant to the administrative hearing process may be enforced by filing a civil suit to collect the penalty and to obtain an injunction that prohibits specific conduct that violates the ordinance; or requires specific conduct necessary for compliance with the ordinance.

If adopted, the Code Official will utilize the City's existing hearing officer contract.
