

ORDINANCE NO. 20141023-015

**AN ORDINANCE SETTING THE COUNCIL MEETING SCHEDULE FOR
CALENDER YEAR 2015.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Except as otherwise provided by council action, the council shall hold its regular meetings and work sessions in 2015 as provided in Exhibit A attached to this ordinance and incorporated in this ordinance for all purposes. 
