Additional Backup Information

Chapter 26 of the Texas Parks and Wildlife Code provides that the use of parkland for non-park purposes may be approved upon a finding that there is no feasible and prudent alternative to the use of this land and the project includes all reasonable planning to minimize harm to the land resulting from the use.

Austin Water Utility is proposing to construct approximately ±230 linear feet of 8-inch wastewater line to tie into the existing wastewater system located in Little Walnut Creek District Park. The proposed wastewater line will be primarily contained within an existing public utility easement. Approximately 0.176 acres of parkland will be designated for a permanent use wastewater easement and approximately 0.366 acres will be used for temporary use for construction access and installation of the wastewater line. This project will improve the wastewater system in this area and provide service to the adjacent property.

Approval of the use of parkland is made on the condition that all restoration is completed in accordance with the Standard Specifications and Construction Standards of the City of Austin and the Parks and Recreation Department’s “Construction in Parks Specifications.” Austin Water Utility is required to pay all costs associated with the restoration and tree mitigation as part of the site restoration process.

There is no feasible and prudent alternative to the use of the dedicated parkland, which includes all reasonable planning to minimize harm to such lands. The dates of public notification in the *Austin American-Statesman* were October 12, 19 and 26, 2014.
