

## **M/WBE Summary**

Bid documents were distributed to 7 general contractors. Bids were opened on September 25, 2014. Peabody General Contractors, Inc. submitted the lowest responsive bid of two bids received:

Peabody General Contractors, Inc., Dripping Springs, TX	\$6,278,106.00
Santa Clara Construction, Ltd., Austin, TX	\$8,803,745.00

AWU's budget for this contract is limited to \$2,000,000 per year. Due to the nature of the work and extent of bid items required to properly bid the contract, the total bid prices exceeded the \$2,000,000 AWU is limited to award. As a result, the contract amount does not equal the bid amount provided by the accepted low bidder.

The contractor's choice of work methodology provides for 8 areas of subcontracting opportunities which are listed below. Project participation goals stated in the solicitation were 1.91% African American, 5.04% Hispanic, 0.63% Native/ Asian American, and 1.83% WBE. Total participation was estimated on contract award amount of \$2,000,000:
