

RESOLUTION NO. 20141118-001

WHEREAS, on November 4, 2014, a special municipal election was held to present to the voters one proposed bond proposition for which voters were given the option of voting “for” or “against;” and on the same date a general municipal election was held for the purpose of electing a Mayor (at large) and City Council Members (single member districts) for District 1, District 2, District 3, District 4, District 5, District 6, District 7, District 8, District 9, and District 10; and

WHEREAS, the returns of the special election have been made to the Council and show that the votes for and against the proposition were cast as follows:

WHEREAS, of the two candidates who received the highest number of votes cast for the office of Mayor, those being Steve Adler and Mike Martinez, neither candidate received a majority of all votes cast for Mayor; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 1, those being Ora Houston and DeWayne Lofton, neither candidate received a majority of all votes cast for City Council Member District 1; and

WHEREAS, Delia Garza received a majority of all votes cast for the office of City Council Member District 2; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 3, those being Susana R. Almanza and Sabino "Pio" Renteria, neither candidate received a majority of all votes cast for City Council Member District 3; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 4, those being Gregorio "Greg" Casar and Laura Pressley, neither candidate received a majority of all votes cast for City Council Member District 4; and

WHEREAS, Ann Kitchen received a majority of all votes cast for the office of City Council Member District 5; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 6, those being Don Zimmerman and James "Jimmy" Flannigan, neither candidate received a majority of all votes cast for City Council Member District 6; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 7, those being Leslie Pool and J.E. "Jeb" Boyt, neither candidate received a majority of all votes cast for City Council Member District 7; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 8, those being Ellen Troxclair and Ed Scruggs, neither candidate received a majority of all votes cast for City Council Member District 8; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 9, those being Kathie Tovo and Chris Riley, Chris Riley has withdrawn as a candidate from the runoff election; and

WHEREAS, of the two candidates who received the highest number of votes cast for the office of City Council Member District 10, those being Mandy Dealey and Sheri Gallo, neither candidate received a majority of all votes cast for City Council Member District 10; **NOW, THEREFORE**,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

The Council finds that all of the recitals contained in this resolution are true and adopts them as findings of fact by this governing body; and

The Council finds that the results of the special election as tabulated, received, and canvassed reflect the votes cast at the election; and

The Council accepts and approves the returns for the special election, as tabulated, received, and canvassed, and declares that Proposition No. 1 is not adopted.

The Council finds that the results of the general election as tabulated, received, and canvassed reflect the votes cast at the election; and

The Council accepts and approves the returns for the general election, as tabulated, received, and canvassed, and declares that the following persons are declared elected and may qualify for the office indicated for terms that begin January 6, 2015:


City Council Member District 2	Delia Garza
City Council Member District 5	Ann Kitchen
City Council Member District 9	Kathie Tovo; and

In order to elect a Mayor, City Council Member for District 1, City Council Member for District 3, City Council Member for District 4, City Council Member for District 6, City Council Member for District 7, City Council Member for District 8, and City Council Member for District 10, the City Council shall order a runoff election as soon as is practicable and no later than the fifth day after this canvass as required by state law (Tex. Elec. Code § 2.024).

With this canvass, Council is making official the precinct returns received from the counties.
