PROPOSAL

Demolish a ca. 1917 house that is contributing to the Historic District, and construct a new house.

ARCHITECTURE

One-story, rectangular-plan, raised, side-gabled frame house with a partial-width, front-gabled independent porch; single and paired 1:1 fenestration; garage in a wood-sided battered frame at the street level.

RESEARCH

The house was built around 1915; the first occupants were Ford C. and Irene Benham; he was a rate clerk and inspector for the State Fire Insurance Commission; they moved to Dallas by 1920, where he was in the fire insurance business. John P. and Tennie McDonald rented this house in the late 1910s and early 1920s. McDonald was the son of a former Austin mayor, and had been in the gravel business before becoming a cement contractor. His obituary stated that he was also a house builder in town. By 1930, he had purchased the house next door, at 1206 W. 8th Street, and was living there with his wife. By 1940, he and Tennie were living on the Fredericksburg Highway (now South Lamar Boulevard). He died in 1945. Sterling and Bertha Kinser are listed as the owners and occupants of the house from the late 1920s through the early 1940s. Kinser grew up on a farm in Burnet County, and was a cashier for the Austin Street Railway Company before becoming a real estate and insurance salesman for Harrison-Wilson. The house was then sold to an absentee owner, who rented it to Albert and Sydna Ater from the mid-1940s through the mid-1950s. Albert Ater was in the banking business; he was the cashier and comptroller at the old Austin National Bank while he and his wife lived in this house. The house ws a rental property again through the late 1950s; it was then purchased by Juan and Hortencia Hipolito, who lived here until the mid-1970s. Juan Hipolito had several jobs with the public schools – school bus driver, and school custodian, while Hortencia Hipolito was a teacher at Matthews School.

STAFF COMMENTS

The house is contributing to the West Line National Register Historic District.


SPECIFICATIONS FOR THE NEW HOUSE

The proposed house is two-stories with a one-car garage at grade (the existing house has a "garage" storage area at grade, and is a raised cottage). The proposed house is very contemporary in style, and will have stone veneer at grade framing the one-car garage, stucco siding, and a wall of glass in a one-story cube that becomes the street presence of the house. The two-story section of the house is set back from the projecting "cube" and is stucco with large sections of horizontal glass. The one-story section of the house is 12 feet above the at-grade garage; the second story rises another 12 feet above the first-story section of the house. The house will have a flat roof. The proposed house has the same front setback as the adjacent houses, and the two-story section of the house is set back 12.5 feet from the front plane of the house, with the mass of the second story 20 feet behind the front plane of the house.

STAFF RECOMMENDATION

Release the demolition permit after the completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, and approve the plans for the new house. While staff laments the loss of a contributing house within the historic district, this house has been neglected for years and is in a deteriorated condition; the proposed new house, while exhibiting a very contemporary style, is compatible with the scale of the contributing houses in the district.

BIOGRAPHICAL NOTES

Ford C. and Irene Benham (ca. 1915 – ca. 1917)

Ford C. and Irene Benham are listed in the 1920 U.S. Census for Dallas, Texas, where they owned their house. Ford Benjam was 32, had been born in Texas, and was in the fire insurance business. Irene Benham was 29, had been born in Texas, and had no occupation listed. They had 2 young children. With them lived Ford's brother, Buell, 27, who was also in the fire insurance business.

Ford Clark Benham's 1917 World War I draft registration card indicates that he was living in Waco, Texas at the time and was a fire insurance inspector for the State Fire Insurance Commission in Austin. He died in 1944 in Lubbock, Texas.

John P. and Tennie McDonald (ca. 1917 – ca. 1925)

John P. and Tennie McDonald are listed as the renters of this house in the 1920 U.S. Census. John P. McDonald was 47, had been born in the United States, and was a cement contractor; Tennie McDonald was 44, had been born in Texas, and had no occupation listed. They had a 14-year old son named Roy, who had been born in Texas. The 1930 U.S. Census shows John P. and Tennie McDonald living next door at 1206 W. 8th Street; they owned the house, which was worth \$4,500. John P. McDonald was 57, had been born in Kansas, and was a road building contractor; Tennie McDonald was 54, had been born in Texas, and had no occupation listed. Their son, Roy, was not listed with them.

In 1910, they lived at 706 West Avenue; the census report of that year shows an older son, Richard, who was 13. John P. McDonald is listed as the proprietor of a gravel pit.

JOHN P. MCDONALD

John P. McDonald, 73, died at his residence, 1706 Fredericksburg road, Saturday morning. He was a general contractor and had constructed many of Austin's fine residences before his retirement 15 years ago. He was the son of John McDonald, mayor of Austin at the time the first dam was built.

He is survived by his wife, Mrs. Tennie Ford McDonald; two sons, Roy William McDonald of New York and Richard Ford McDonald of Austin; one brother, Charles McDonald of San Antonio; and one sister, Miss Grace McDonald of Phoenix, Ariz.

Funeral services will be held at the Weed Corley Funeral home Sunday at 4 p. m. The Rev. Fred E. Brooks will officiate and burial will be in Oakwood cemetery.

Sterling P. and Bertha Kinser, Jr. (ca. 1928 – ca. 1943)

The 1930 U.S. Census shows Sterling P. and Bertha Kinser as the owners of this house, which was worth \$3,000. Sterling P. Kinser was 27, had been born in Texas, and was the cashier for the streetcar company. Bertha Kinser was 25, had been born in Texas, and had no occupation listed. They had a son, John D., 4. With them lived Bertha's brother, Roy Rebell, 20, a Texasborn trainman for the streetcar company. The 1940 U.S. Census shows them as the owners of this house, which was worth \$3,000. S.P. Kinser was a real estate salesman. Bertha Kinser had no occupation listed. Their son, John Dolph, was 13.

The 1920 U.S. Census shows Price Kinser as the 16-year old son of Sterling P. and Nannie A. Kinser, who owned a farm in Burnet County. The elder Sterling Kinser had been born in Tennessee; the rest of the family had been born in Texas.

KINSER, Sterling P. (S.P.), 2520 Jarratt Ave., died Tuesday. Services 3:30 p.m. Thursday at Weed-Corley Funeral Home.

The 1930 U.S. Census shows Albert and Sydna Ater living with her mother, Kate Baldwin, a 79-year old divorcee, at 401 W. 39th Street. Albert Ater was a bank clerk. Sydna Ater had no occupation listed.

ATER, Albert Henry, 85, 1818 W. 36th St., died Monday. Services pending at Cook-Walden Funeral Home. Survivors: wife, Sydna Ater of Austin; sister, Mrs. Roy Potts of Cedar Park.
