

**RESOLUTION NO. 20141230-**

**WHEREAS**, on November 4, 2014, a general municipal election was held for the purpose of electing a Mayor (at large) and City Council Members (single member districts) for District 1, District 2, District 3, District 4, District 5, District 6, District 7, District 8, District 9, and District 10; and

**WHEREAS**, the canvass of the November 4, 2014 general municipal election reflected that no candidate received a majority of all votes cast in the election for the office of Mayor or for the offices of City Council Member for District 1, District 3, District 4, District 6, District 7, District 8, District 9, and District 10; and

**WHEREAS**, in the election for the office of City Council Member for District 9, Chris Riley timely withdrew as a candidate from the runoff election; and

**WHEREAS**, the Austin City Charter states that, in an election for a place on the Council, if no candidate receives a majority of all votes cast for such place at the election, the Council shall immediately upon declaring the official results of the election call for a runoff election for every place to which no one was elected; and

**WHEREAS**, the City Council adopted Ordinance No. 20141118-002 calling a runoff election to elect a Mayor (at large), and City Council Members (single member districts) for District 1, District 3, District 4, District 6, District 7, District 8, and District 10; and

**WHEREAS,** a runoff election was held on December 16, 2014; and

**WHEREAS,** the returns of the December 16, 2014 runoff election have been made to the Council and show the votes for Mayor and City Council Members were cast as follows:
