## ORDINANCE NO. 20141211-098

AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND COSTS, AND WAIVING CERTAIN REQUIREMENTS FOR THE CITY COSPONSORED 2015 AUSTIN FARMER'S MARKET EVENTS AT REPUBLIC SQUARE PARK AND TRIANGLE PARK, DURING THE 2015 CALENDAR YEAR.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. This is one of the City co-sponsored special events under Resolution No. 021003-40. The total fee waivers authorized for this event are estimated at $\$ 148,148$. Additionally, the Austin Transportation Department refundable security deposit requirement of $\$ 2,000$ and the Parks and Recreation Department refundable damage deposit requirements of $\$ 1,300$ ( $\$ 1,000$ for Republic Square Park, $\$ 300$ for Triangle Park) are also being waived. Any fee requirements above this total are the responsibility of the applicant.

PART 2. Council waives and reimburses certain fees for 2015 Austin Farmer's Markets as follows:
