PROPOSAL

Demolish a ca. 1917 house that is contributing to the Historic District and construct a new house.

ARCHITECTURE

One-story, rectangular-plan, front-gabled raised bungalow with a central, partial-width, shed-roofed independent porch; single 1:1 fenestration with 3:1 wood screens.

RESEARCH

The house was built in 1917; the first known occupants were L. (Leander) Fletcher and Nannie Walker, who lived here until 1919. L. Fletcher Walker was a Louisiana-born carpenter who had come to Austin and was living with his carpenter brother before he got married. He worked at Kuntz-Sternenberg Lumber Company. James T. and Katie Logue lived here in 1920 - he was from San Antonio, where he had worked as a trunk-maker; while living here, he was a trunk-maker for Robert Mueller and Brother, the city's largest luggage manufacturer at the time. Around 1921, the house was owned and occupied by William R. and Neffie Warrick. William R. Warrick was a clerk with the U.S. Post Inspector's Office. He later moved to Fort Worth and continued in the same occupation there. The Warricks lived here until around 1934. Norman and Jessie Metz rented the house in the late 1930s. Norman Metz was originally from New Braunfels, and was an accountant and rate clerk for the Missouri Pacific Railroad. From just after World War II until their deaths in the 1970s, the house was the home of Russell and LaVada Rees. Russell Rees worked for the State Employment Commission for many years. After LaVada Rees died in 1979, the house was rented out for a short time, but then occupied by their daughter, Annette, who was married to Dave Troxell; they are listed as the residents in the 1992 city directory.

PROPOSAL FOR NEW CONSTRUCTION

The applicant proposes the construction of a new house that will have a front-gabled one-story presence on the street, and a large, two-story front-gabled mass behind it. The front portion of the house will be raised above grade as is the existing house, with a wraparound front porch, there will be a front-gabled section of the second story starting behind the porch, and a larger, two-story mass behind it. The proposed new house will have hardiplank siding.

STAFF COMMENTS


The existing house is listed as contributing to the West Line National Register Historic District.

STAFF RECOMMENDATION

Recommend that the applicant retain the front portion of the existing house to respect its contributing status within the historic district, and to set the addition further back from the front of the house so as to not compromise its integrity to an unacceptable degree. The applicant has designed this house with a bungaloid-esque front section, but the existing house could easily be used as the front section of the proposed house and retain the historic

character of the site. The two-story mass should be set behind the one-story section of the house to the greatest extent possible, so as to not loom over the one-story section. This house is set on a hillside, so the addition will be less visible from the street because of the height of the house above the street, but the two-story section of the house still appears to overwhelm the one-story section in violation of general design guidelines for additions to contributing houses within historic districts. In any case, the applicant should complete a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES:

L(eander) Fletcher and Nannie Walker (ca. 1917 – ca. 1919)

Leander Fletcher Walker's 1917 World War I draft registration card shows that he was living at this address. He was born June 1, 1892 in Washington, Louisiana, and that he was a carpenter for Kuntz-Sternenberg Lumber Company in Austin. He was married and had a child.

Fletcher Walker appears in the 1910 U.S. Census living with his brother, J.F. Walker at 1016 E. 6th Street in Austin. He was 16, had been born in Louisiana, and was a carpenter doing odd jobs. His brother, J.F., was 26, had been born in France, and was also an odd jobs carpenter.

James T. and Katie Logue (ca. 1919 – ca. 1921)

James T. and Katie Logue appear in the 1920 U.S. Census as the renters of this house. James T. Logue was 35, had been born in Tennessee, and was a trunk-maker in a trunk factory. Katie Logue was 32, had been born in Kansas, and had no occupation listed. They had a 4-yar old daughter, Ruth, who had been born in Texas. He and Katie were living in San Antonio in 1918, according to his World War I draft registration card, which shows that he was working as a trunk maker there. By 1930, he and Katie were again living in San Antonio, where he was working as a salesman. James T. Logue died in San Antonio in 1957.

William R. and Neffie Warrick (ca.1921 – ca. 1934)

The 1930 U.S. Census shows William Ross and Neffie Warrick as the owners of this house, which was worth \$3,500. William R. Warrick was 33, had been born in Texas, and was a Post Office clerk. Neffie Warrick was 34, had been born in Texas, and was a saleslady in a store. They had 2 children together: Dorothy Warrick, 10; and William A. Warrick, 8, as well as Neffie's son, Ben Henry Derson, 14. All of the children had been born in Texas.

The 1940 U.S. Census shows that William R. Warrick was now married to a woman named Margaret, and they were living in Fort Worth. William R. Warrick was an inspection clerk for the Post Office. Margaret Warrick was 29, had been born in Texas, and had no occupation listed. Margaret had a daughter, Sylvia Ballard, 5. With them also lived Margaret's mother, Lydia Eastment, a 60-yar old Virginia-born widow with no occupation listed.

Norman A. and Jessie Metz (ca 1936 – ca. 1943)

Norman and Jessie Metz appear as the renters of this house in the 1940 U.S. Census. Norman Metz was 38, had been born in Texas, and was a rate clerk and accountant for the Missouri Pacific Railroad. Jessie Metz was 31, had been born in Texas, and had no occupation listed. They had a daughter, Mary Lynn, 1. The 1930 U.S. Census shows Norman Metz as the 28-

year old son of August and Ellie Metz of New Braunfels, Texas. Norman Metz was a ticket clerk for the railroad. His father was a butcher in a butcher shop.

Norman A. Metz

Norman A. Metz, 89, of Austin, passed away Wednesday.

Mr. Metz was an active member of the University Presbyterian Church for over 50 years.

Survivors include wife, Jessie Metz, Austin; daughter, Mary Sewell, Waco; grandchildren, Lisa Harper, Dallas and Mark Sewell, Germany; greatgrandchild, Jessica Harper, Dallas; and a niece, Ellen Armstrong, Houston.

Russell L. and LaVada Rees (ca. 1946 – ca. 1979)

The 1940 U.S. Census shows Russell and Lavada Rees living in Albany, Texas, where they owned a home. Russell Rees was 42, had been born in Illinois, and was a tool dresser for an oilfield drilling company. Lavada Rees was 38, had been born in Texas, and had no occupation listed. They had 2 daughters, Marjorie, 11, and Ilene, 2. Both girls had been born in Texas. His World War I draft registration card shows that Russell L. Rees was born in Chicago in 1897, and was a cream tester for the Edmonton City Dairy in Edmonton, Alberta. The 1920 U.S. Census shows him living in Spokane, Washington, where he was the book-keeper for a lumber company.

Lees was a member of the United Pentecostal Church, and the Hill City Lodge No. 456

AF&AM. He had been a resident of Austin and Travis
