Authorize award and execution of a 24-month requirements service contract with MARINE OUTLET, INC. to provide repair services for boats and boat engines in an amount not to exceed \$196,988, with four 12-month extension options in an amount not to exceed \$98,494 per extension option, for a total contract amount not to exceed \$590,964.

Amount and Source of Funding

Funding in the amount of \$65,663 is available in the Fiscal Year 2014-2015 Operating Budget of the Fleet Service Department. Funding for the remaining 16- months of the original contract period and extension options are contingent upon available funding in future budgets.
