
Importance of the Court System

The building still has *significant* deficiencies.



The Search for a Site

Timeline

- **2006 - 2008 – County contracted an analysis of 4 sites between 11th Street, 9th Street, San Antonio and Lavaca**
 - Capital View Corridors have major impact on construction height
 - Legislative relief from View Corridors discussed in multiple sessions
- **2009 – County contracted for Central Campus (Downtown) Master Plan**
 - Oct. 2009 – Community Charrettes indicated no site for a Civil & Family Courthouse
- **Dec. 2010 – Site acquired**
- **Nov. 2011 – Central Campus Master Plan approved by Commissioners Court**





- **Those functions not required to be downtown moved to North Campus**
- **Central Campus reserved for Justice and “the Seat of County Government” aka Commissioners Court**
 - Civil Justice
 - Criminal Justice

Airport Fit Analysis



4 Courts Per Floor **6 Courts Per Floor**



- **RED** – Represents volume of Court that would exceed height restrictions.
- Height restriction exceeded by:
 - Approx. 200 ft. (4 courts per floor)
 - Approx. 120 ft. (6 courts per floor)

Current Mixed-Use Plans for Airport Blvd


- **Offices:** 80,000 square feet for Tax Office & HHSVS
- **Housing:** 175-200,000 square feet of housing, affordable & market rate options, plus community amenity space
- **Retail:** 10-20,000 square feet on ground floor
- **Parking:** 300-500 parking spaces (a net increase of 150-350 spaces)



Palm School Site Fit Analysis

- **Historic structure on site is a significant design challenge**
- **Parking limited to Judicial and In-Custody movement**
- **No Staff or Public Parking**





Note - 6 Courts Per Floor not Possible on Site

Palm School Location - 8 Routes




Courthouse Site - 54 Routes




Palm School Challenges

- Site is less accessible
 - Fewer Cap Metro Bus Lines
 - Limited access to public parking
 - No staff parking available
 - Complicated vehicle access
- No revenue opportunity from parking
- No development potential for expansion beyond initial courts structure
- Proposed setbacks & easements for 2nd Street and Sabine support mixed use pedestrian oriented street frontages
- Historic structure will be costly to design around for a Courts structure




Historic Location

- The Civil & Family Courthouse will be on site originally planned to house the Courthouse dating back to 1839
- The first Courthouse occupied the site with a jail from 1855 to 1874




1839 Plan of the City of Austin - the 'Waller Plan'

The CFCH location is one of the most accessible locations in all of Travis County.



Every major CapMetro bus route through downtown, stops at or near the site.




The Lance Armstrong Bikeway along 3rd Street (south side of site) is projected to be completed in 2016.

Why Downtown?

- Law Firms represent 32.1% of Class A office space
- 6729 Attorneys Practicing in Travis County
- Half of all practicing attorneys are downtown
- Top 25 Law Firms – 21 in 78701
- Need substantial support: law firm employees, Court Reporters, and other legal vendors
- Approximately 350 Travis County employees
- Courthouse draws large number of daytime patrons
 - 250,000+ annually
 - Encourages demand for commercial office space
- Texas counties with pop. > 1M have courthouse in CBD (Central Business District)

Density of Law Firms in Austin




Occupants

- **Departmental Space Program approved by Commissioners Court**
 - October 14, 2014
- **Provides definition for space needs in building thru 2035**
- **14 stories**
 - Bottom 7 floors (departmental)
 - Top 7 floors (court floors)
- **28 Courtrooms (Initial build out); 33 Courtrooms (2035)**
- **Offices for 35 Judicial Officers**
- **Higher trafficked departments on lower floors**


Circulation Zones




TYPICAL COURT FLOOR PLAN


Summer Midday




Winter Midday


- Auction Oaks not shaded by CFCH - April 10th – September 1st


