

## M/WBE Summary

Public notice was given for this Solicitation (CLMC513, Mabel Davis Channel Structure Reconstruction and Retrofit) through the City's Vendor Connection web portal which resulted in 677 contractors receiving notification. Eleven general contractors obtained the bid documents and five bids were received and opened on December 17, 2014. The Smith Contracting Co. Inc. submitted the lowest responsive bid of the five bids received.
