John O’Brien, Owner of Fado’s Irish Pub, has submitted a street event application for the closing of the following street for a fee paid event. A fee paid event is defined as any right of way event that is in a fixed or stationary location and requires the payment of a gate fee to access the public right of way. The promoter will be charging \$15.00 entry fee for adults and free for children under the age of 12.

**Street Affected:** 200 block of West 4<sup>th</sup> Street

**Street:** 200 West 4<sup>th</sup> Street.

**Closed:** From March 17, 2015 at 5:00 a.m. through March 18, 2015 5:00 a.m.

**Open:** March 18, 2015 at 5:01 a.m.

**Event Times:** From 5:00 a.m. - March 17, 2015 through midnight March 18, 2015

Temporarily closing any portion of a street for a Street Event that requires the public to pay to enter the closure area

requires City Council approval under Section 14-8-3 (B) of the City Code. The applicant is in the process of complying with all other requirements for this street event. The Transportation Department recommends approval subject the applicant complying with all other street closure requirements.

**Fee Breakdown:**

Gate Fee – \$15.00 from Noon until Midnight (12:00am)

Street Event Application Fee      \$250 for arterials

Sound Permit Fee                      \$33.00 of per day (1-day)

Safety Inspection Fee                \$152.00 (\$38.00 per hours = 2 hours x 3)

Street Event Permit Fee              \$400.00 (\$200.00 per day x 2 days)

Security Deposit                        \$2000.00 (refundable upon written request)

**Total:**                                    **\$2835.00**
