



**AUSTIN CITY COUNCIL
MINUTES**

**SPECIAL CALLED MEETING
THURSDAY, FEBRUARY 19, 2015**

The City Council of Austin, Texas convened in a Special Called Meeting on Thursday, February 19, 2015, City Hall, 301 W. Second Street, Austin, Texas.

Mayor Adler called the meeting to order at 9:10 a.m.
