



I am currently being sued in an election contest filed by an unsuccessful candidate for City Council District 4 in the 2014 Election. Under Article III, Section 8(H) of the Charter, a Council Member involved in an election contest may solicit and accept contributions for the purpose of that election contest. In the interest of full disclosure and transparency, I will hold those funds in a Special Officeholder Account and report the contributions and expenditures on periodic C/OH reporting forms.
