DISCUSSION AND POSSIBLE ACTION ON APPLICATIONS FOR HISTORIC**

**DISTRICT ZONING APPLICATIONS, and REQUESTS TO CONSIDER THE INITIATION OF A HISTORIC ZONING CASE**

**1. Un-numbered**

**Pine Street Station, 414 Waller Street**

The case comes on the citizen communication by Regi Thomas and Liz Purcell for the Commission to consider the initiation of a historic zoning case for the ca. 1925 Humble Oil and Refining Company warehouse, also known as Pine Street Station.

Staff Recommendation: Postpone to January 26, 2015 at the applicant's request.

**MOTION: Postpone the public hearing to January 26, 2015 on a motion by Commissioner Galindo. Commissioner Leary seconded the motion; Commissioner Limbacher recused on account of her absence at the previous meeting; vote 4-0.**

**2. Un-numbered**

**Stasswender House and possibly associated cottages**

**Roughly bounded by 16<sup>th</sup> Street, Waller Street, and IH-35 Northbound service road.**

The case comes on citizen communication for the Commission to consider the initiation of a historic zoning case for the Stasswender House on E. 16<sup>th</sup> Street, and related houses on E. 16<sup>th</sup> Street and Waller Street. Commissioner Myers offered to perform research on the history of the house and cottages at the last Commission meeting and present those findings to the Commission.

Staff Recommendation: Staff makes no recommendations regarding potential Commission action to initiate historic zoning cases upon citizen requests.

**Old Judges' Hill Local Historic District**

**Roughly bounded by West Avenue on the east, 15<sup>th</sup> Street on the south, Shoal Creek Boulevard on the west, and W. Martin Luther King, Jr. Boulevard on the north.**

Staff Recommendation: Postpone to January 26, 2015 at the applicant's request.

Proposal: Repair a failed stone wall at the west wall of the Nueces Street parking lot; repair the carriage house addition.

Committee Recommendation: Not reviewed

Staff Recommendation: Approve as proposed.

**MOTION: Approve the repairs by consent on a motion by Commissioner Leary. Commissioner Galindo seconded the motion; vote 4-0 (Wolfenden-Guidry recused).**

2. **C14H-1990-0007 – Nelson Davis Warehouse  
117 W. 4<sup>th</sup> Street**

Proposal: Install a cover to the previously-approved rooftop canopy; install a sign on the railing of the rooftop deck; umbrellas and other furniture on the rooftop.

Applicant: RA Sushi Restaurant

City Staff: Steve Sadowsky, Historic Preservation Office, 974-6454

Committee Recommendation: Not reviewed

Staff Recommendation: Approve the canopy cover and the railing sign; deny the umbrellas and other rooftop furniture for being in the rooftop use setback.

John McCall and Aaron Albright spoke in support of the proposed installations.

Commissioner Limbacher requested clarification as to the position of the umbrellas. Commissioner Myers voiced opposition to rooftop decks within historic districts. Commissioner Limbacher requested clearer drawings; Commissioner Leary concurred. Commissioner Limbacher requested that the applicant appear at the January Certificate of Appropriateness Committee meeting. Commissioner Wolfenden-Guidry requested that the applicant provide spec sheets and change the color of the umbrellas from red to black. Commissioner Leary suggested modification to the stationary parts of the canopy.

Proposal: Demolish a house that was moved onto the site in 1963 and construct a new house.

Staff Recommendation: Approve as proposed with the recommendation that the applicant consider wood-framed windows to increase the compatibility with the historic character of the district.

Staff Recommendation: Approve as proposed with the recommendation that there be a vertical stone element that differentiates the historic house from the proposed addition.

**1801 Mohle Drive (Old West Austin)**  
Proposal: Demolish a ca. 1946 house and construct a new house.  
Applicant: Ross Frie  
City Staff: Steve Sadowsky, Historic Preservation Office, 974-6454  
Staff Recommendation: Release the demolition permit and recommend that the applicant reconsider the style of the proposed house and use the

character of the contributing houses within the district as a strong guide in designing the new structure, particularly for a one-story presence on the street and the incorporation of more Colonial Revival-style elements.

Tim Allen spoke in support of postponement. Ross Frie and Chris Little spoke in opposition to postponement.

Proposal: Demolish a ca. 1961 house.

Staff Recommendation: Encourage adaptive re-use and retention of the house if feasible, then relocation over demolition, but release the permit.

No speakers; passed on consent.

**MOTION: Release the permit in accordance with the staff recommendation, on a motion by Commissioner Leary. Commissioner Galindo seconded the motion; vote 5-0.**

Proposal: Demolish a ca. 1950 house.

Staff Recommendation: Encourage re-use and retention of the house if feasible; otherwise, release the permit upon completion of a City of Austin Documentation Package.
