Overview of the Pedestrian Advisory Council

The Pedestrian Advisory Council (PAC) shall advise the City of Austin on pedestrian planning, policy, design, funding, education, and enforcement efforts regarding the creation, maintenance and operation of pedestrian facilities in order to ensure a safe and enjoyable circulation for both commuting and recreation within the City of Austin. The PAC's goal is to ensure sensitivity to pedestrian issues in the design and implementation of all public and private projects impacting pedestrians.

History

The PAC originated in 2013 when citizens convened for a summit on walkability issues led by America Walks. The intent of the summit was to catalyze community-based efforts to increase walkability, highlight walkability as an issue, and involve stakeholders with varied experiences and expertise. Austin participants at the summit identified the need for a local pedestrian organization, resulting in the Pedestrian Advisory Council's creation.

Membership Diversity and Meeting Participation

In 2014, the PAC achieved its goal of membership diversity. Members represent a full-range of pedestrian interests and abilities as well as differing ages, genders, geographies, and economic perspectives. This ensured that members of the PAC represent the City as a whole. To establish operational procedures and to help perform the work of the Pedestrian Advisory Council, several subcommittees and working groups were created. These included a Technical Subcommittee, Project Subcommittee, Bylaws Subcommittee and Elections Subcommittee. Multiple departments, groups, and agencies attended meetings of the group to increase knowledge and dialogue about citywide efforts affecting pedestrian mobility and safety in Austin.

- **Planning and Development Review Urban Design Division:** Placemaking, Great Streets, and Wayfinding programs
- **Planning and Development Review:** Land Development Code recommendations, walkability assessment results and South Shore planning efforts
- **Public Works:** Sidewalk program, urban trails master plan, safe routes to school, street reconstruction and sidewalk maintenance
- **Right of Way Management Division of Transportation Department:** Pedestrian hybrid beacon safety devices, construction barriers
- **Active Transportation Program of Transportation Department:** Bike Master Plan, Parking Management Districts and Pedestrian Hybrid Beacons, Complete Streets
- **TxDOT, Reconnect Austin:** I-35 cut and cap proposal, diamond interchange
- **Police Department:** Jaywalking initiatives, community safety
- **Capital Metro:** Urban Rail and Downtown Station improvements
