

### M/WBE Summary

Public notice was given for this solicitation (CLMC526, Barrington Way FM Reroute and Gravity System Upgrade) through the City's Vendor Connection web portal which resulted in 449 contractors receiving notification. 11 general contractors obtained the bid documents and 7 bids were received and opened on February 5, 2015. Facilities Rehabilitation Inc. submitted the lowest responsive bid of the 7 bids received.
