

REGULAR MEETING THURSDAY, APRIL 2, 2015

Invocation: Pastor Rodney Shaw, New Life Pentecostal Church

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, April 2, 2015 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 10:30 a.m.

CONSENT AGENDA

The following items were acted on by one motion.

- 1. Approve the minutes of the Austin City Council special called meeting of March 23, 2015, work session of March 24, 2015 and regular meeting of March 26, 2015.
 - The minutes from the City Council special called meeting of March 23, 2015, work session of March 24, 2015 and regular meeting of March 26, 2015 were approved on consent on Council Member Zimmerman's motion, Council Member Houston's second on an 11-0 vote.
- 2. Authorize execution of an interlocal agreement with Caldwell County for the installation, maintenance, and repair of Caldwell County's wireless communications equipment for a 12-month term for an estimated amount not to exceed \$5,000 payable to the City and with annual automatic renewal terms in the same estimated amount per renewal.
 - The motion authorizing the execution of an interlocal agreement with Caldwell County was approved on consent on Council Member Zimmerman's motion, Council Member Houston's second on an 11-0 vote.
- 3. Authorize award and execution of a construction contract with SMITH CONTRACTING COMPANY, INC. for the 3rd Street Reconstruction Phase 4 Guadalupe Street to Nueces Street Project in the amount of \$3,895,282.50 plus a \$389,528.25 contingency, for a total contract amount not to exceed \$4,284,810.75. (Notes: This contract will be awarded in compliance with City Code Chapter 2-9A Minority Owned and Women Owned Business Enterprise Procurement Program by meeting the goals with 5.72% MBE and 2.56% WBE participation.)
 - The motion authorizing the award and execution of a construction contract with Smith Contracting Company, Inc. was approved on consent on Council Member Zimmerman's motion, Council Member Houston's second on a 10-0 vote. Council Member Zimmerman abstained.

6. Approve an ordinance authorizing acceptance of supplemental grant funds in the amount of \$29,485 from the TEXAS DEPARTMENT OF STATE HEALTH SERVICES, COMMUNITY PREPAREDNESS SECTION; and amending the Fiscal Year 2014-2015 Health and Human Services Operating Budget Special Revenue Fund (Ordinance No. 20140908-001) to support public health emergency preparedness activities.

There was a motion made by Council Member Troxclair and seconded by Council Member Houston to approve the resolution with the following amendment.

The amendment was to delete the third "Be it Further Resolved" paragraph.

There was an amendment made by Council Member Troxclair and seconded by Council Member Houston to amend the amendment by putting back in the year 2016. The amendment failed on a vote of 5-6. Those voting aye were: Mayor Adler and Council Members Gallo, Houston, Renteria and Troxclair. Those voting nay were: Mayor Pro Tem Tovo and Council Members Casar, Garza, Kitchen, Pool and Zimmerman.

There was an amendment made by Council Member Zimmerman and seconded by Council Member Pool to strike the years 2016 and 2017. The amendment passed on a vote of 7-4. Those voting aye were: Mayor Adler, Mayor Pro Tem Tovo and Council Members Casar, Garza, Kitchen, Pool and Zimmerman. Those voting nay were: Council Members Gallo, Houston, Renteria and Troxclair.

There was a motion made by Council Member Kitchen and seconded by Council Member Pool to amend the "Now, "Therefore, be it Resolved by the City Council of the City of Austin:" clause by striking the words "or the Texas Event Trust Fund". The amendment passed on an 11-0 vote.

Resolution No. 20150402-004 was approved with the previous amendments on Council Member Troxclair's motion, Council Member Houston's second on a 7-3 vote. Those voting aye were: Mayor Adler and Council Members Gallo, Garza, Houston, Kitchen, Renteria and Troxclair.

Those voting nay were: Council Members Casar, Pool and Zimmerman. Mayor Pro Tem Tovo abstained.

5. Approve an ordinance establishing classifications and positions in the classified service of the Austin Fire Department; creating and eliminating certain positions and repealing Ordinance No. 20140908-004 relating to the Austin Fire Department classifications and positions.

Those voting aye were: Council Members Houston and Zimmerman. Those voting nay were: Mayor Adler, Mayor Pro Tem Tovo and Council Members Casar, Gallo, Garza, Kitchen, Pool, Renteria and Troxclair.

Ordinance No. 20150402-005 was approved on Council Member Pool's motion, Council Member Garza's second on a 9-3 vote. Those voting aye were: Mayor Adler, Mayor Pro Tem Tovo and Council Members Casar, Gallo, Garza, Kitchen, Pool and Renteria. Those voting nay were: Council Members Houston, Troxclair and Zimmerman.

Waivers

Approve a waiver of the requirement in Section 2-1-21(H) of the City Code for the appointment of James Shieh. The waiver allows his simultaneous service on the Design Commission and Planning Commission.

There was a motion made by Mayor Adler and seconded by Council Member Houston to postpone the appointment of Sharon Blythe to the Parkland Events Task Force and Parks and Recreation Board. The motion passed on a vote of 10-1. Council Member Zimmerman voted nay.

15. Approve a resolution initiating a code amendment to mitigate the effects of smoke emissions from restaurants and mobile food vendors near residentially zoned areas. (Notes: SPONSOR - Council Member Sabino "Pio" Renteria CO 1: Council Member Kathie Tovo CO 2: Mayor Steve Adler CO 3: Council Member Gregorio Casar)

There was a motion made by Council Member Renteria and seconded by Mayor Adler to approve the resolution.

There was an amendment made by Mayor Adler and seconded by Council Member Gallo to amend the resolution by having the "Be it Resolved by the City Council of the City of Austin:" and the last "Be it Further Resolved" read as follows. The amendment was accepted by the maker of the motion.

Be it Resolved by the City Council of the City of Austin:

"Council initiates an amendment to the City Code to address smoke from cookers, restaurants, trucks and their impact on residents provisions to consider shall include but not be limited to those to require restaurants and mobile food vendors that utilize a wood or charcoal burning stove or grill located within 100 feet of the nearest property line of a property zoned as residential base district or property used for a residential use to take appropriate action to mitigate the impact of smoke emissions on the health and quality of life of surrounding residents by relocating smoke-emitting equipment to exceed the aforementioned distance or installing smoke-mitigating devices."

Be it Further Resolved:

"The City Manager is directed to present the proposed ordinance and associated recommendations consistent with this resolution to the Planning Commission and the Planning and Neighborhoods Committee of Council for consideration no later than the first meeting after July 31, 2015."

There was an amendment made by Council Member Gallo and seconded by Council Member Houston to have this item go back to the Economic Opportunity and the Health and Human Services Committees. The amendment was approved without objection.

There was an amendment made by Council Member Casar and seconded by Council Member Pool to strike the Planning Commission and the Planning and Neighborhoods Committee from the last "Be it Further Resolved" clause. The amendment was approved without objection.

There was an amendment made by Council Member Garza and seconded by Council Member Kitchen to amend the "Be it Resolved by the City Council of the City of Austin: " to read, "Council initiates a possible amendment to the City Code..." and the next to the last "Be it further Resolved:" to read, "The City Manager is directed to initiate a stakeholder input gathering process to provide an opportunity for affected residents and business owners to provide recommendations." The amendment was approved without objection.

There was an amendment made by Council Member Kitchen to amend the next to the last "Be it further Resolved:" to read, "The City Manager is directed to initiate a stakeholder input gathering process to provide an opportunity for affected residents, business owners and other stakeholders to provide recommendations." The amendment was approved without objection.

There was a motion made by Zimmerman and seconded by Mayor Adler to refer to Council committee. The motion failed on a vote of 1-10. Council Member Zimmerman voted aye.

Direction was given to staff to provide:

- More information from AISD regarding the pilot program.
- A copy of the result of the feasibility study of a new civil penalty ordinance for unlawfully passing a stopped school bus conducted by the City Manager's office.
- The impact this would have on the municipal courts and the police department's case load.

There was a motion made by Mayor Pro Tem Tovo and seconded by Council Member Renteria to approve the resolution.

There was a motion made by Council Member Zimmerman to strike the wording "the City Manager is directed to return" and replace it with "The Public Safety Committee is directed to return to Council". The motion died for lack of a second.

There was an amendment made by Council Member Troxclair and seconded by Council Member Zimmerman to direct the City Manager to bring the ordinance back to the Public Safety Committee. The amendment was accepted without objection.

There was a friendly amendment made by Mayor Pro Tem Tovo to amend the previous amendment made by Council Member Troxclair to include the wording "The City Manager is further directed to provide that ordinance to the Public Safety Committee prior to its Council scheduling for its review and recommendation." The amendment was accepted by the maker and Council Member Zimmerman, who made the second.

Ordinance No. 20150402-021 was approved with the previous amendments on Mayor Pro Tem Tovo's motion, Council Member Renteria's second on an 11-0 vote.

ITEM(S) REFERRED FROM COUNCIL COMMITTEE(S)

Approve a resolution directing the City Manager to identify funding options from the current budget for five full-time equivalent staff positions for the Mayor's Office and \$25,000 for each council office for the purpose of providing enhanced constituent services.(Item from Council) (Notes: SPONSOR: Mayor Steve Adler CO 1: Council Member Leslie Pool CO 2: Council Member Sheri Gallo CO 3: Council Member Ann Kitchen)

There was a motion made by Council Member Zimmerman and seconded by Mayor Adler to approve the resolution with the following language.

"Whereas, the new 10-1 City Council has made, and continues to make, significant changes in the way that City business is conducted in Austin; and

Whereas, there has been, and continues to be a shift of more authority to the Mayor and to Council Members-such as their ability to determine their own staff (as authorized by Proposition 12 that was approved by Austin voters as recently as 2012); and

Whereas, given the expansion of responsibilities that the Mayor and Council Members find themselves confronted with, it is necessary to provide to the Mayor and to Council Members the additional human resources that are called for in order to properly carry out the added responsibilities that the Mayor and Council Members are required to address; Now, Therefore,

Be it Resolved by the City Council of the City of Austin:

The City Manager is directed to temporarily re-allocate from the existing City budget, vacant positions and funding for the equivalent of three FTEs at salaries not to exceed that of a sitting council member, and funding for associated benefits, to the Mayor's office personnel budget, and vacant positions and funding for the equivalent of one FTE, at a salary not to exceed that of a sitting council member, and funding for associated benefits, to each council office personnel budget. The number of and amount paid to mayor or council office staff members, is the decision of that elected officeholder, within the maximums established by the current budget and this resolution."

There was a friendly amendment made by Mayor Pro Tem Tovo to add the language "Positions or funding will return to the originating department absent an affirmative vote at the Council to continue funding these positions in the FY16 budget." The amendment was accepted by the maker and Mayor Adler, who made the second.

There was an amendment made by Council Member Troxclair and seconded by Council Member Houston to cap the salary of the Council staff by not exceeding the average Council staff salary. The amendment passed on a vote of 7-4. Those voting aye were: Mayor Pro Tem Tovo and Council Members Casar, Gallo, Garza, Houston, Pool and Troxclair. Those voting nay were: Mayor Adler and Council Members Kitchen, Renteria and Zimmerman.

Resolution No. 20150402-026 was approved with the previous amendments on Council Member Zimmerman's motion, Mayor Adler's second on a 9-2 vote.
